## Re: Freedom of Information Request FOI-000033-2015 Request Refusal

#### Dear

I refer to the Freedom of Information Act 2014 and your submission to this body dated 15/10/2015 and received on 15/10/2015.

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

"The number of gardai or staff at An Garda Siochana who were disciplined for improper use of the garda Internet services, data and social media the years 2012/13/14."

wish to inform you that your request has been refused. I,

The purpose of this letter is to explain my decision.

### 1. Findings, particulars and reasons for decision

I am refusing your request on the basis that the records are not readily identifiable and it would cause a substantial and unreasonable disruption in Human Resources and People Development of An Garda Síochána to inspect all manual records held to identify this particular type of behaviour. Section 15(1)(c) of the Freedom of Information Act 2014 is as follows:

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where—
  - (c) in the opinion of the head, granting the request would, by reason of the number or nature of the records concerned or the nature of the information concerned, require the retrieval and examination of such number of records or an examination of such kind of the records concerned as to cause a substantial and unreasonable interference with or disruption of work (including disruption of work in a particular functional area) of the FOI body concerned,

With reference to your request I wish to make you aware that disciplinary proceedings initiated internally relating to improper use of Garda internet services, data and social media on Garda equipment is not specifically identifiable under a separate heading within the discipline section in Human Resources and People Development. However improper use of internet services, data and social media by Gardaí on Garda equipment may lead to a breach of discipline under a more generic section of the Garda Síochána (Discipline) Regulations 2007 as amended. These Regulations are available at <a href="https://www.oireachtas.ie">www.oireachtas.ie</a>.

As no records exist in the format you have requested you may wish to reconsider your search parameters and provide a more specific search relevant to the information you seek based on the Garda Síochána (Discipline) Regulations 2007 as amended.

In accordance with the requirements of section 15(1)(c) of the Freedom of Information Act 2014 I am refusing your request.

# 2. Right of appeal
