I refer to the Freedom of Information Act 2014 and to your submissions to this body, dated and received on the 15th of October 2015.

Part 1 Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included Agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is show below:

-Records outlining the number of complaints filed by members of An Garda Siochana in relation to bullying within the workforce for the years 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014 and the first nine months of 2015.

-In addition, I request records outlining the various examples of bullying that were given to the Human Resource Management Division when a complaint was filed.

have now made a final decision to part grant your request on 5th I, November 2015.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decisions to deny access

Under Part 1, Section 2 (Interpretation) of the Freedom of Information Act, 2014, the effective date under Subsection (c) is defined as:

"in the case of an entity that immediately prior to enactment of this Act, was not a public body within the meaning of the Act of 1997, but is a public body within the meaning of this Act, 21 April 2008, unless provision is made to the contrary by order under section 6;"

As An Garda Síochána was not an included body prior to the commencement of the Freedom of Information Act, 2014, we can only provide information from 21st April 2008. Therefore the information you sought for 2006, 2007 and up to 21st April 2008 cannot be provided to you.

Table 1 shows you the number of complaints made from 21st April 2008 to November 2015.

The figures shown above refer to complaints relating to all forms of bullying which includes harassment and sexual harassment. Examples of complaints received comprise of incidents where a person was isolated or excluded, undermined, abused verbally or physically, being tasked with unachievable goals or deadlines and harassed or victimised.
