I refer to the Freedom of Information Act 2014 and to your submissions to this Body, dated 14/10/2015 and received on the 15/10/2015.

Part 1 Schedule 1 of the Freedom of Information Act 2014 states that An Garda Siochana is listed as a partially included Agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

"Records outlining the sums of compensation paid to members of the force for personal injuries sustained while on duty in 2009, 2010, 2111, 2012, 2013, 2014 and the first nine months of 2015. The records sought would cover each year individually, if possible. Records outlining how many officers were compensated in each of those years for personal injuries sustained in duty.

Records providing a breakdown of the type of injuries sustained by members of the force in those years."

The awards made would also include claims for medical expenses and loss of earnings.
