I refer to the Freedom of Information Act 2014 and to your submissions to this Body, dated 13th February 2016 and received on the 15th February 2016.

Part 1 Schedule 1 of the Freedom of Information Act 2014 states that An Garda Siochana is listed as a partially included Agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is show below:

I respectfully request to know the following for all members of an Garda Siochána between 2000 and 2015, broken down by quarter and year.

- Date of discharge
- Type of discharge
- Corresponding length of service in months
- Rank at time of discharge
- Reason for discharge

I note that it was agreed in discussions with a member of my staff that agreed to amend your request to seek annual figures of discharges by rank from 2008 to 2015.

I wish to inform you that you requested has been granted.

Appendix 1 provides summary information on discharges from An Garda Síochána in the period 2008 to 2015.

The figures include all types of discharge including voluntary retirement and compulsory retirement on reaching the maximum service age. It also includes members who have been discharged on medical grounds or died in service.

CNER relates to the Cost Neutral Early Retirement scheme. Under this scheme a member may retire early on reduced benefits subject to certain conditions. Details of the scheme are available at http://circulars.gov.ie/pdf/circular/finance/2005/10.pdf.

I advise that the manner of recording these statistics prior to 2011 does not allow for the collation of the reason for discharge by rank. However, I provide details of number of discharges by ranks and by reason separately.
