I refer to the Freedom of Information Act 2014 and my correspondence to you of 21st October 2015 and to your submissions to this body, dated and received on 20th October 2015.

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matter". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

'An annual break-down detailing the level of staff on long term sick leave (6 weeks or more) as a percentage of the force.

-An annual break-down detailing the level of staff on stress-related sick leave as a percentage of the force.

I am seeking the information for 2015, 2014, 2013, 2012 and 2011 for comparative purposes'.

Ι, wish to inform you that your request is part granted.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decisions

The first part of your request sought an 'annual breakdown detailing the level of staff on long term sick leave (6 weeks or more) as a percentage of the force'. In An Garda Siochána, a sickness absence is classified as long-term when it is a continuous absence of 28 days or more (4 weeks). The table below shows the number of Garda members who availed of long term sick leave (28 days or more) as a percentage of the force in the years 2011 - 2015 (1 Jan - 30 Sept).

YEAR	No. members who availed of long term sick leave (28 days or more) as a % of the force
2011	10.9%
2012	12.2%
2013	13.0%
2014	9.5%
2015 Jan-Sep	6.3%

Please note the Total No. of Sick Days recorded are the number of calendar days that staff are absent, including those members who are absent due to being injured on duty and may also include weekends and rest days.

Your request further sought an 'annual break-down detailing the level of staff on stress-related sick leave as a percentage of the force'.

Following the introduction of the Sickness Absences Management System, sickness absences are recorded under the following categories – Ordinary Illness; Occupational Injury/Illness arising from Duty and Critical Illness.

There is currently no specific sub-category for the recording of 'stress related illnesses'. Therefore, each instance of sickness absence throughout each year from 2011 - 2015 to date would need to be manually accessed on to ascertain if the illness is associated with a stress related illness. In 2014 alone, there were 19,184 sickness absence instances.

Section 15(1)(c) of the Freedom of Information Act 2014 states that:

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where—
 - (c) in the opinion of the head, granting the request would, by reason of the number or nature of the records concerned or the nature of the information concerned, require the retrieval and examination of such number of records or an examination of such kind of the records concerned as to cause a substantial and unreasonable interference with or disruption of work (including disruption of work in a particular functional area) of the FOI body concerned,

I am refusing your request on the basis that the records are not easily identifiable and it would cause a substantial and unreasonable disruption to the Human Resources and People Development section of An Garda Siochána to inspect all sickness absence records held to identify these records.

2. Rights of appeal

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
