I refer to the Freedom of Information Act 2014 (FOI Act) and your submission to An Garda Síochána dated 13th September, 2016 and received on 11th September, 2016.

Your original request has been segregated into three individual requests and this letter refers to parts (a), (d) and (f) of same.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

- a) For the amount of new recruits who have been assigned to (i) the Roscommon/Longford Garda Division and (ii) the Sligo/Leitrim Garda Division since January 1, 2015, and how many retires in the same division since the same date.
- d) a record of staffing levels of An Garda Siochana in each of the divisions listed previously in each of the following periods - currently; (ii) Dec 31, 2015, (iii) Dec 31, 2014, (iv) Dec 31, 2013.
- f) The number of attacks on gardai in each of these divisions while on duty since 2011 until present, broke down annually and by each of the two divisions. I would also like a list of the injuries sustained.

I wish to inform you that I have decided to grant your request on 4th October, 2016.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decisions.

On receipt of your request, the Human Resources and People Development (HRPD) Section were requested to provide records relating to your request.

Part (a) of your request is seeking 'the amount of new recruits who have been assigned to (i) the Roscommon/Longford Garda Division and (ii) the Sligo/Leitrim Garda Division since January 1, 2015, and how many retires in the same division since the same date'.

Table A below sets out the number of recruits who have been assigned to the Roscommon/Longford and Sligo/Leitrim Divisions with effect from 1st January 2015.

The latter section of part (a) of your request enquires as to how many retires in the same division since the same date? The statistics recorded in the HRPD include the number of overall departures from An Garda Síochána and the reasons for departures are not broken down on a Divisional level. Therefore, the figures contained in table B below are inclusive of all departures from An Garda Síochána with effect from 1st January 2015. Departures include retirements, resignations, medical discharges, dismissals and deaths in (i) Roscommon/Longford Division and (ii) Sligo/Leitrim.
