Face Covering – Public Transport Vehicle (Summary)

On the {DATE OF OFFENCE} at {PLACE OF OFFENCE} in [SAID DISTRICT], did fail to comply with a request of a relevant person, {INSERT NAME}, namely: you failed to {wear a face covering / remain off the public transport vehicle / alight from the public transport vehicle} in contravention of Regulation 7(4) of Health Act 1947 (Section 31A – Temporary Restrictions) (Covid-19) (Face Coverings on Public Transport) Regulations 2020 as amended.

Face Covering – Certain Premises (Summary)

On the {DATE OF OFFENCE} at {PLACE OF OFFENCE} in [SAID DISTRICT], without reasonable excuse, entered or remained in a relevant premises in a relevant geographical location without wearing a face covering in contravention of Regulation 4(1) of Health Act 1947 (Section 31A – Temporary Restrictions) (Covid-19) (Face Coverings in Certain Premises and Businesses) Regulations 2020 as amended.

Contrary to Section 31A(6)(a) of the Health Act 1947 as amended by Section 10 of the Health (Preservation and Protection and other Emergency Measures in the Public Interest) Act 2020 and contrary to section 31A(12) of the Health Act 1947 as substituted by Section 3 of the Health (Amendment) Act 2020.

Movement of Persons (Summary)

On the {DATE OF OFFENCE} at {PLACE OF OFFENCE} in [SAID DISTRICT], without reasonable excuse, did leave your county of residence in contravention of Regulation 3(1) of Health Act 1947 (Section 31A - Temporary Restrictions) (Covid-19) (No. 9) Regulations 2020 as amended.

Contrary to Section 31A(6)(a) of the Health Act 1947 as amended by Section 10 of the Health (Preservation and Protection and other Emergency Measures in the Public Interest) Act 2020 and contrary to section 31A(12) of the Health Act 1947 as substituted by Section 3 of the Health (Amendment) Act 2020.

Event in Dwelling (Summary)

On the {DATE OF OFFENCE} at {PLACE OF OFFENCE} in [SAID DISTRICT], being a person who was not resident in the said dwelling or resident in a paired dwelling, did attend an event in a dwelling located in a relevant geographical location, without reasonable excuse, which was held for social or recreational reasons, contrary to Regulation 6(1) of Health Act 1947 (Section 31A - Temporary Restrictions) (Covid-19) (No. 9) Regulations 2020 as amended.

Contrary to Section 31A(6)(a) of the Health Act 1947 as amended by Section 10 of the Health (Preservation and Protection and other Emergency Measures in the Public Interest) Act 2020 and contrary to section 31A(12) of the Health Act 1947 as substituted by Section 3 of the Health (Amendment) Act 2020.

Event in Dwelling - Organiser (Summary)

On the {DATE OF OFFENCE} at {PLACE OF OFFENCE} in [SAID DISTRICT], did organise an event in a dwelling located in a relevant geographical location, without taking reasonable steps to ensure those persons attending or proposed to attend the event, were part of the same household as you or part of your paired household contrary to Regulation 4(1) of Health Act 1947 (Section 31A - Temporary Restrictions) (Covid-19) (No. 9) Regulations 2020 as amended.

Contrary to Section 31A(6)(a) of the Health Act 1947 as amended by Section 10 of the Health (Preservation and Protection and other Emergency Measures in the Public Interest) Act 2020 and contrary to section 31A(12) of the Health Act 1947 as substituted by Section 3 of the Health (Amendment) Act 2020.

Event - Organiser (Summary)

On the {DATE OF OFFENCE} at {PLACE OF OFFENCE} in [SAID DISTRICT], did organise a relevant event within a relevant geographical location without taking the necessary steps to ensure that the number of persons attending at, or otherwise participating in, the relevant event did not exceed 15 people in number, contrary to Regulation 7(2) of Health Act 1947 (Section 31A - Temporary Restrictions) (Covid-19) (No. 9) Regulations 2020 as amended.
