## Message from the Commissioner

During the month of June 2025, An Garda Síochána welcomed 120 new recruits, following a passing out ceremony in the Garda College on 6 June 2025. The recruits from Intake 243 have now been deployed to operational responsibilities across the country.

I'm pleased to say that our Garda strength now stands at 14,276, as of 30 June 2025, while Garda Staff strength stands at 3,675. Meanwhile, a further 170 new Garda Trainees have now commenced their training at the Garda College as part of Intake 252.

Also this month, An Garda Síochána launched the Transforming An Garda Síochána 2018-2024 Report, which set out the journey of change and transformation being undertaken by An Garda Síochána in recent years, following publication of the Report of the Commission on the Future of Policing in Ireland (CoFPI) in 2018.

With the publishing of this report, we now close out our journey under the A Policing Service for Our Future reform programme. However, work continues within An Garda Síochána to deliver on key goals which will enable us to grow our capabilities, and ensure we can provide a modern and high-quality community-based policing service to the public.

Work continues in the area of Roads Policing, and this month we conducted an extensive operation over the course of the June Bank Holiday weekend, running from Thursday, 29 May 2025 to Tuesday, 3 June 2025. Over the course of the operation, An Garda Síochána conducted more than 830 Mandatory Intoxicant Testing (MIT) checkpoints. Over 4,000 breath tests and approximately 270 oral fluid tests were carried out, leading to 167 arrests for suspected driving under the influence of an intoxicant. Additionally, almost 3,000 drivers were detected exceeding speed limits throughout the weekend.

Over the entire month of June 2025, 3,946 MIT checkpoints were conducted, where an average of eight arrests were made per day nationally for driving under the influence of drugs and 15 per day for driving under the influence of alcohol.

An Garda Síochána continues to appeal to all road users to never drive under the influence of alcohol or drugs, to slow down and to always choose a speed that is appropriate to the driving conditions, to wear your seatbelt and keep your eyes always on the road.

## 1. Financial Expenditure and Receipts

An Garda Síochána has a gross allocation for 2025 of €2.48b split between €2.31b operating budget (current) and €173.1m capital expenditure. In addition, €16.59m of capital funding has been carried forward from 2024 into 2025. At the end of June 2025, total gross expenditure is €1.26b (51% of allocation) and receipts are €76.68m (68% of allocated).

- Pay (including College) in June 2025, is €823.21m year to date (YTD), which is €24.71m over the budget profile of €798.50m.
- Non-pay (including College) in June 2025 (YTD) is €139.06m, which is €7.44m under the budget profile of €131.62m.
- Capital in June 2025 (YTD), is €73.31m, which is €15.71m over budget profile of €57.59m (YTD). Note: deferred capital of €16.59m excluded.
- Appropriations in Aid in June 2025 (YTD) of €76.68m is €19.26m over budget profile of €57.42m.

Overall, June 2025 net expenditure is in line with budget profile. However, there has been an overspend in overtime which is under review. In addition, there is overspend in towing expenses, with underspend in superannuation costs, clothing, road traffic equipment along with higher receipts in appropriations in aid.

An Garda Síochána met with the Department of Justice and the Department of Public Expenditure NDP Delivery and Reform in April 2025, as part of the Garda Budgetary Oversight and Resourcing Group, to present the current status on overtime and to discuss the plans to return to the approved budget.

The five largest drivers of overtime year to date are crime investigation (23%), other recurring (19%), court (15%), crime prevention (13%) and briefing time (10%). Court and pre-tour briefing time are not in the direct control of An Garda Síochána management. Proactive management of overtime, including a regional focus, is ongoing with a particular emphasis on the drivers of overtime.

### Estate Management

Works continue at Bailieboro, Portlaoise and Newcastle Garda Stations, and are the subject of active engagement between the OPW and An Garda Síochána. In addition, other projects at earlier stages of development, such as the upgrading of PEMS in Drogheda, Tallaght and Naas, are being progressed in conjunction with the OPW. Works are anticipated to commence end of Q3 / early Q4 2025 on the development of new Garda stations at Clonmel and Macroom.

## 2. People and Development

### New Gardaí attested in June 2025

On 6 June 2025, 120 Probationer Gardaí were attested from Intake 243, and enjoyed a lovely day celebrating with family and friends. We were pleased to welcome 170 Garda Trainees to commence their training programme as part of Intake 252.



### The strength of Garda personnel is growing

As at 30 June 2025, Garda member strength stood at 14,276, and the Garda Staff strength stood at 3,675. A full breakdown by rank, grade and gender is outlined below.

### 3. Corporate Communications

Throughout the month of June 2025, the Office of Corporate Communications continued to communicate internally and externally on a broad range of policing activities undertaken by An Garda Síochána. During this month, we conducted a number of media briefings in support of operational activities across the organisation.

This included the launch of the 'Transforming An Garda Síochána 2018-2024' Report at Garda Headquarters, which included a briefing with Commissioner Drew Harris, Deputy Commissioners Shawna Coxon and Justin Kelly, and Executive Director Eimear Bourke on the report. Operational members also presented during the briefing highlighting improvements made within the organisation over the course of the 'A Policing Service for Our Future' programme.

Other activities of note included an update on the roll-out of electric vehicles in the Garda Fleet at Wexford Garda Station on 4 June 2025; a graduation ceremony at the Garda College, Templemore on 6 June 2025; and the launch of the Donegal Rally Roads Policing Operation with the PSNI on 18 June 2025.

The Office of Corporate Communications conducted a media event at Wexford Garda Station to unveil the Wexford/Waterford Garda Division electric vehicle fleet. A total of 24 electric vehicles are now operational within the division, which sees frontline uniformed community policing in the Wexford District now fully electric.

Over 20 of these electric vehicles were on display at Wexford Garda Station for the event along with a bank of chargers. The event served to illustrate An Garda Síochána commitment to introduce electric vehicles and electric vehicle chargers nationally, to compliment petrol and diesel vehicles, and to embrace more sustainable transport solutions.

### Garda Press Office Activity

The Garda Press Office operates from 7am-11pm, seven days a week, responding to hundreds of queries, coordinating external communications and media relations, and regularly updating our social media platforms.

This office issued 157 press releases, including 55 missing person appeals in respect of 27 individuals; 21 witness appeals; together with those related to successful operations undertaken by the organisation during the month of June 2025.

### Social Media Activities

The Office of Corporate Communications oversees six official social media channels for An Garda Síochána; Facebook, Instagram, TikTok, LinkedIn, X (formerly Twitter) and Bluesky. Within these channels there are 43 separate accounts, including regional Facebook and regional Instagram profiles. There are approximately 2.3 million followers across all platforms. These channels are used to promote activity within the organisation, highlighting the good work being done nationwide. These channels are further used to provide key communications to the public on behalf of An Garda Síochána. These communications may include public information regarding traffic disruption, public appeals for information, alerts i.e. Child Rescue Ireland (CRI) alerts and campaigns.

The Office of Corporate Communications measures the success of these communications by capturing:

- The number of followers/individual users who have subscribed to each account.
- The rate of engagement with the account. A high percentage indicates we are producing compelling posts that resonate with our audience. Typically, a good engagement rate is in the region of 1-5%.

## Internal Communications

In June 2025, An Garda Síochána Internal Communications Team delivered seven issues of Newsbeat. The average Newsbeat open rate is 66%, higher than the industry standard open rate of 57.17% for internal newsletters, and the 52.26% average within Government and Public Service organisations.



Newsbeat highlights from June 2025 include:

- Notice issued on Distracted Driving day-of-action which took place on 25 June 2025 nationwide.
- Launch of the Drug Related Intimidation and Violence Engagement (DRIVE) National Awareness Campaign.
- A notice on the annual Garda Public Attitudes Survey (PAS), which seeks the views of a sample of adults and young people on issues relating to An Garda Síochána, crime and policing in Ireland.

#### **4. Operating Model**

Following the implementation of the Operating Model in the Kildare/Carlow Division on 11 May 2025, all 21 divisions are now operating under the Operating Model Four Functional Area structures (Business Services, Performance Assurance, Crime and Community Engagement).

The four Regional Offices have commenced implementation of standardised processes:

Wave 1 – Performance Assurance

Wave 2 – Finance and Logistics

Wave 3 – General Administration

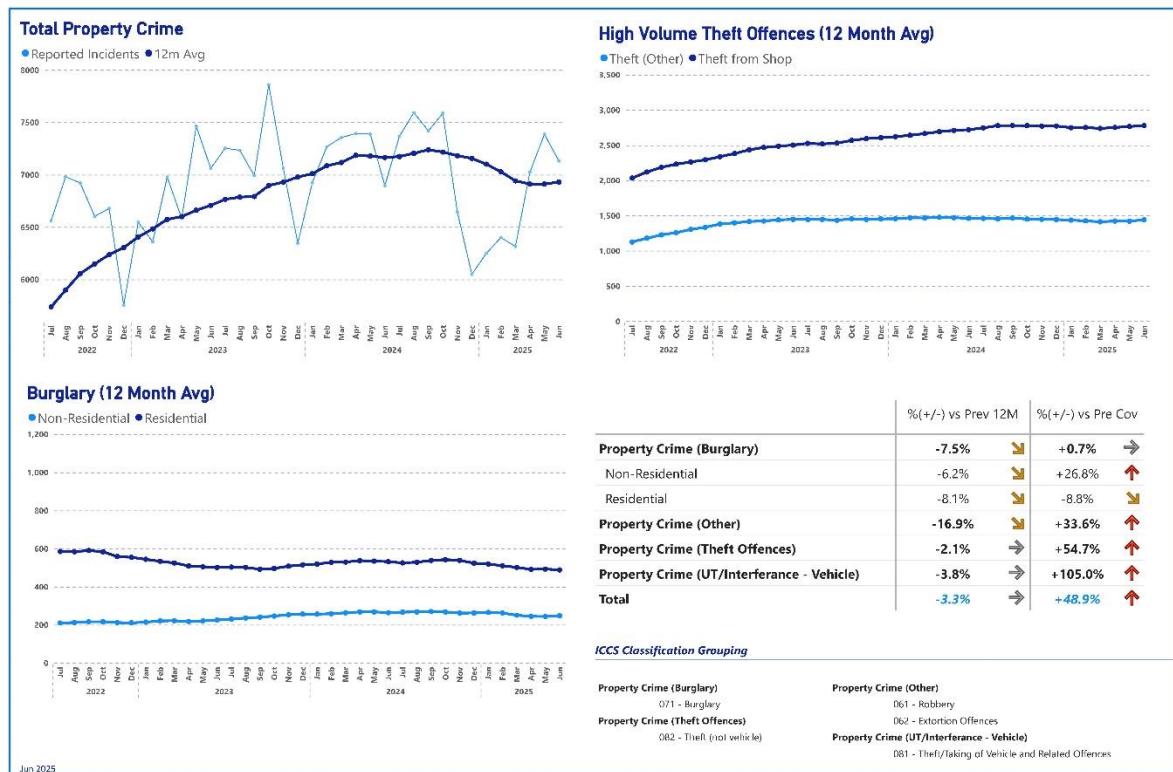
Wave 4 – the HR processes will commence in early course across all four Regional Offices.

National functions have been engaged and presented with a common 'national blueprint design'. All functions have been requested to formally feedback on the blueprints.

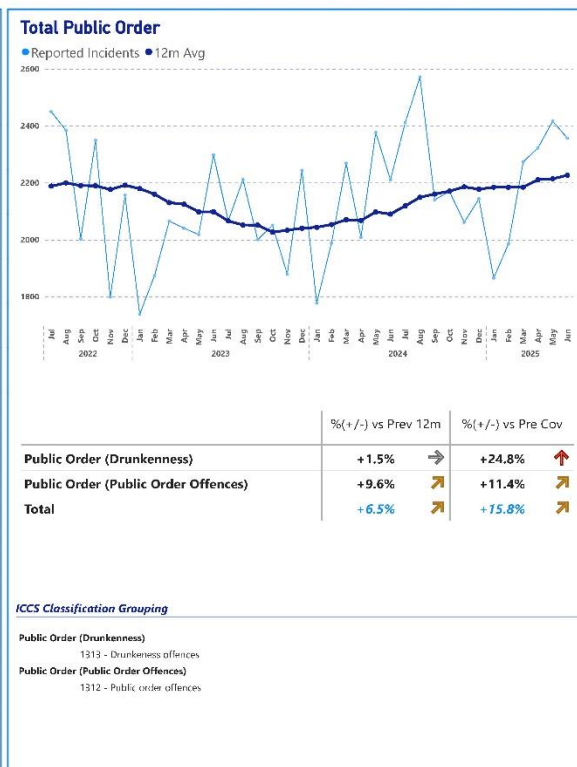
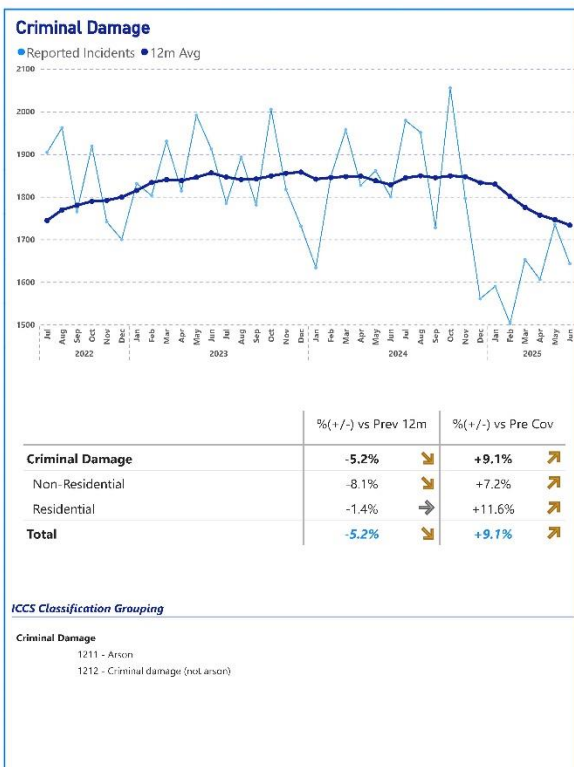
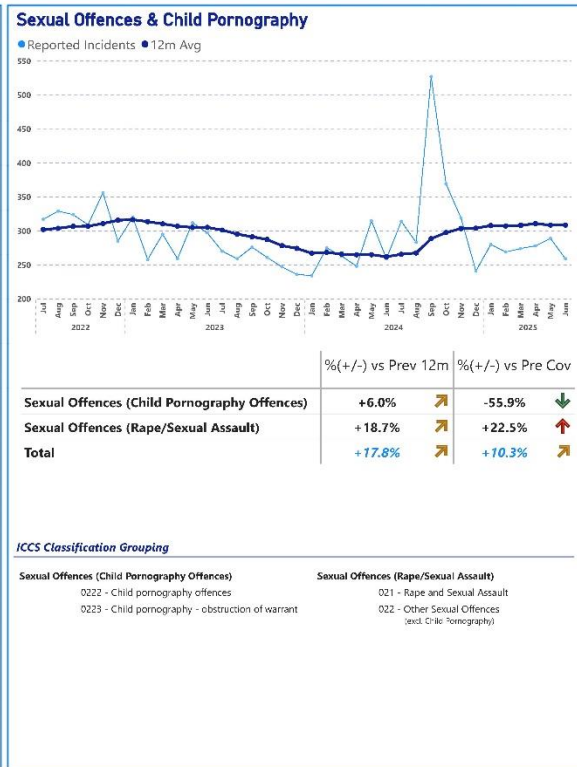
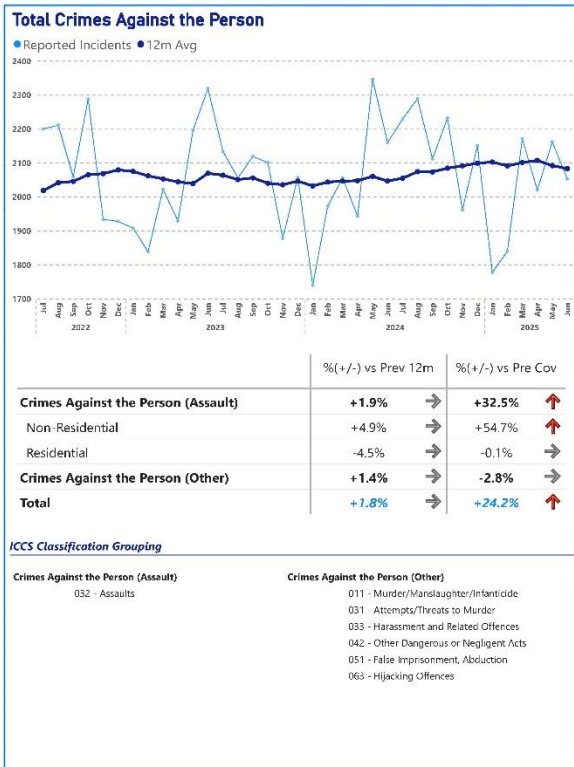
## 5. Crime Trends

This feeds directly into planning operational activities aimed at reducing and preventing crime. Crime incident figures and the associated trends are based on provisional data, and are subject to change following review. The CSO publications represent the official crime statistics. These are carried in the CSO's quarterly publications of crime trends and in their annual reports.

## 6. Policing Challenges

### Demonstrations

An Garda Síochána continue to provide a policing response, including traffic management, to protests nationally. The Israel/Palestine conflict, and anti-immigration/housing of refugees, continue to be the main themes of protests/demonstrations. Of the total number of protests and demonstrations, 76 were held across the DMR during June 2025, with two arrests made for public order offences. The largest protest comprised of 4,000 people attending an anti-immigration demonstration at the Garden of Remembrance, Parnell Square, Dublin.

### Policing at Events

The planning for, resourcing and policing of major events continues to provide a challenge in terms of policing resources. June marked a particularly busy month for policing, security and traffic management in the Dublin Metropolitan Region. In addition to a number of sporting and cultural events, there were a number of concerts at venues across the city and summer social events, including the series of concerts in Malahide Castle and the Aviva stadium.

### Roads Policing

An Garda Síochána continues to respond to road safety challenges. In June 2025, 13 people died in fatal collisions. There were 90 serious injury collisions reported in June 2025.

An Garda Síochána continues to implement the 30-minute roads policing initiative which was introduced in April 2024, to increase visibility on our roads. In June 2025, there were 3,946 MIT checkpoints conducted.

There was an average of eight arrests per day nationally for driving under the influence of drugs, 15 per day for driving under the influence of alcohol and there were more than 2,800 vehicles seized under the provisions of Section 41 of the Road Traffic Act, in June 2025.

## 7. Community Engagement

### **Bord Bia Bloom Festival 2025**

Gardaí from the Garda National Community Policing Unit and the Garda National Community Engagement Bureau organised a stand at An Bord Bia Bloom Festival 2025 over the June Bank Holiday weekend to promote the work of An Garda Síochána. The stall featured an array of interactive activities designed to appeal to visitors of all ages. The popular Garda cut-out stand, designed to foster positive interactions with Gardaí, drew enthusiastic responses from families. There was representation from the Garda National Cyber Crime Bureau and the Garda National Economic Crime Bureau, offering crime prevention advice. The Garda Band provided a performance at the Bloom stage, much to the delight of the crowds attending. The Garda Mounted Unit provided a presence at the event and assisted with positive engagement with visitors to the Garda stand.

The festival also served as a platform to display An Garda Síochána commitment to modernisation and sustainability, featuring a fleet of new vehicles which included An Garda Síochána Dublin Castle Roads Policing BikeSafe initiative. There was also a proof of concept tri-city motorbike currently being considered by An Garda Síochána, emphasising the organisations' efforts to explore ways for effective policing capabilities. Additionally, the Garda Community Engagement Van was on site, symbolising An Garda Síochána dedication to enhancing community outreach and accessibility. This van is customised to serve as a mobile hub for public interaction, providing information on safety, crime prevention and community programmes. An Garda Síochána presence at Bloom not only showcased their diverse and innovative approaches to policing but also reinforced their role as an integral part of the community, dedicated to building trust and ensuring public confidence.

### **Garda National Crime Prevention Unit's Presentation to the HSE**

On 18 and 25 June 2025, the Garda National Crime Prevention Unit presented to the HSE and its members on crime prevention and personal safety. This presentation provided crime prevention advice to staff nearing retirement within the HSE. Examples of topics covered within the presentation are personal safety, home security and online safety. This is a continuing monthly commitment with members of the National Crime Prevention Unit and the HSE. This commitment has afforded an additional opportunity for An Garda Síochána to engage with our communities, providing practical crime prevention tips and information.

### **Director of the Diversion Programme (GNYDB) attends Safe Futures Project in Lisbon.**

From 19 – 20 June 2025, the Director of the Diversion Programme, Garda National Youth Diversion Bureau attended the kick-off event of the project titled "Safe Futures: Promising Approaches, Opportunities and Barriers for Interventions to Prevent Youth Recruitment and Participation in European Drugs Markets", at the European Union Drugs Agency in Lisbon, Portugal. Safe Futures is a new European Union Drugs Agency funded project by the Research Evidence into Policy Programmes and Practice project (REPPP) Team, University of Limerick which is bringing together policymakers, researchers, law enforcement agencies and practitioners from across Europe to collaborate in a new community of practice. The overall purpose of the project is to enhance drug-related crime prevention efforts in Europe by:

- Establish a multi-disciplinary and jurisdictional community of practice to support and contribute to the project activities.
- Conduct a desk review of literature on interventions, initiatives and evaluations.
- Identify and review existing examples of practices and interventions.
- Identify critical success factors and barriers to development and implementation of interventions.
- Develop a conceptual framework and model to inform development and implementation of interventions.

### **Quarterly Meeting with the Garda Divisional Diversity Inspectors**

On 23 June 2025, the Garda National Diversity Unit (GNDU) facilitated a quarterly meeting with the Garda Divisional Diversity Inspectors. A representative of the Traveller Mediation Service (TMS) was in attendance and the main topics on the agenda were as follows:

- Update from GNDU on developments since the Diversity Conference in February 2025.
- Traveller Mediation Service – Presentation and Q&A.
- Local diversity related issues.
- Sharing of local initiatives/best practice.

### **New Canine Dog in the North Western Region**

On 9 June 2025, the North Western Region received a new canine dog “Gunner” who attended his first checkpoint on-duty. Gunner joined Garda members at a Mandatory Intoxicant Testing (MIT) checkpoint, where they detected two drivers that tested positive at the roadside for the presence of drugs. One vehicle was seized for having no insurance, while several other drivers were issued with fines and penalty points for a range of road traffic offences. The objective of this high-visibility policing activity is to promote awareness, deter drug use, search for drugs and deter both driving under the influence of alcohol, and driving under the influence of drugs.
