Section 1

An Overview of An Garda Síochána

An Garda Síochána is the national police and security service of Ireland, comprised of approximately 14,000 Garda Members, 3,400 Garda Staff and 350 Garda Reserves. An Garda Síochána is a community focused organisation with a mission of 'Keeping People Safe'. With a dual role and responsibility for the provision of policing services, and protecting the security of the State, An Garda Síochána is committed to delivering a responsive, effective and efficient service, that meet the needs of our communities.

The organisation was established over 100 years ago at the inception of the state, and has a proud history of delivering community policing. In order to build upon this strong foundation, An Garda Síochána must continue to evolve, responding as a modern police and security service to the changing face of crime, vulnerability, population and citizen expectation.

An Garda Síochána is charged with delivering on the key commitments made within the Programme for Government. In support of such, the organisation is growing at scale, with the effective use of Garda resources and capabilities as a key focus area.

An Garda Síochána has delivered on a significant organisational transformation programme including the introduction of cutting-edge technology, new methods of working and the biggest change to its structure in its history.

The introduction of a Garda Board is supporting the organisation in becoming more agile and adaptive, while a new Policing and Community Safety Authority is supporting the effective provision and continuous improvement of policing services. These developments and more mean it is a particularly exciting time to join An Garda Síochána and the organisation is determined to recruit the best talent to help deliver its ambitious programme of work.





Section 1

An Overview of Garda Occupational Health & Wellbeing Directorate

Garda Occupational Health and Wellbeing (GOHW) is an executive directorate in An Garda Síochána with responsibility for occupational health and wellbeing of all Garda personnel.

The Chief Medical Officer (CMO) is the Executive Director over GOHW and has organisational responsibility for occupational health and wellbeing across An Garda Síochána with specific responsibilities for strategic leadership and oversight for occupational health services delivery and the health and wellbeing agenda for An Garda Síochána. The CMO also provides medicolegal and advisory function to the Garda Commissioner and the senior leadership team as well as accountability in related matters to the Garda Executive and relevant oversight bodies on behalf of the Commissioner.

GOHW is made up of a team of specialist occupational health nurses and occupational health physicians, health and wellbeing professionals, and a business support team staffed with various administrative grades.

GOHW currently operates a 3-pillar operational structure as follows -

 Garda Occupational Health Service (GOHS) – responsibility for managing and delivering clinical occupational health services including workplace health protection and promotion

Services provided by the GOHS include -

- Manage the medical assessment of Garda Trainee applicants and provide advice on medical suitability for entry.
- Medical assessment of employees to determine fitness for work subsequent to or during sickness absence and advising on workplace adjustments where applicable.
- Health assessment of Garda members for specialised or defined safety critical roles/duties including deployment for overseas missions.
- Mandatory, statutory and risk-based health surveillance for employees undertaking duties with defined workplace hazards exposures.
- Health promotion and improving health awareness amongst employees.
- Giving appropriate medical advice on issues presented where employees are injured in the course of their work.
- Researching and advising on matters pertinent to health and safety specifically as it relates to policing.
- Liaising with outside bodies in relation to medical matters which have relevance to An Garda Síochána.
- Delivering relevant vaccination programmes to employees at risk of occupational exposure to biological hazards.

- 2. Garda National Health & Wellbeing Office (GNWO) responsibility for:
- Strategic development and management of the Health and Wellbeing Strategy.
- Driving implementation of the occupational health and wellbeing agenda.
- Coordinating the engagement and contribution of all stakeholders in the health and wellbeing agenda across An Garda Síochána.
- Develop and manage the Local Health and Wellbeing Partnership Network.
- 3. Garda Chief Medical Officer (CMO) Office responsibility for:
- Management of specific strategic functions and programmes for the CMO.

Section 2 GARDA Job Specification

The Role

Reporting to the CMO or as may be designated, the Occupational Health Physician (OHP) will serve as clinical lead for their assigned GOHS hub/region and work with the existing team to provide occupational health services to promote and maintain the physical, mental and social wellbeing, and work ability of employees of An Garda Síochána in line with the Garda Síochána Health and Wellbeing Strategy and Implementation Plan.

Principal Duties and Responsibilities

The Role of the Occupational Health Physician within their respective occupational health hub/region will include:

Advisory Role

- Provide advice to management on occupational health issues including operation of relevant sections of the Safety, Health and Welfare at Work Act, 1989 2005.
- Participate in An Garda Síochána Working Groups relating to employee health & safety.
- Advise management about dealing with sickness absence and if possible returning workers to the workplace, including their necessary rehabilitation.
- Advise managers about health promotion & health & wellbeing programmes in the workplace.
- In collaboration with the People and Development Directorate, support the development of best practice in the management of attendance.
- Contribute to strategic planning and delivery of occupational health services.

Health Promotion and III Health Prevention

- Support employees in addressing health & wellbeing issues relating to their roles.
- In association with management, identify workplace hazards, facilitate risk assessments as appropriate and implement appropriate monitoring and control mechanisms.
- In conjunction with the Health & Safety Section, facilitate recording & monitoring of workplace accident and injury trends.
- Prevention of work-related ill health and promotion of good health through good work.
- Prevention of non-work related health problems and promotion of health and wellbeing using the
 workplace as a platform for raising awareness of health issues, health literacy and encouraging
 behaviours that promote thriving health and wellbeing.
- Promoting reasonable and practicable workplace interventions for those who develop a health condition or disability.
- Advice on effective workplace rehabilitative measures for employees with impaired work ability whose work performance or attendance is affected by their health.

- In association with relevant sections, support health promotion programmes for employees.
- In association with relevant sections, promote and maintain workplace specific preventive programmes.
- Commit to best practice and maintenance of standards in line with published guidelines for excellence in occupational health practice.
- Support and promote policy and service development in collaboration with the Chief Medical Officer.

Health Assessment & Screening

- Carry out relevant and independent medical examinations of employee referred by management, assessment of employees following serious illness/accidents and review of employees seeking or being considered for retirement on the grounds of ill-health.
- Support the delivery, evaluation and quality assurance of the hepatitis B immunisation programme.
- Participate in the management of blood and body fluid exposure incidents in the course of work, and any other issues relating to employee exposure to biological hazards in the course of their work.

Workplace Epidemiology

- Participate in monitoring and reporting on trends in illness, workplace accidents and health of employees in collaboration with the Health and Safety Section and the Sickness Absence Section.
- In collaboration with Health & Safety Section, ensure that legal and mandatory reporting requirements in relation to notifiable injuries and illnesses are met.

Administrative

- Advisory to Garda management on proactive support for employee health and wellbeing.
- Support the development and implementation of procedures for keeping and securing
 occupational health records by the service, and that professional standards in respect of the
 confidentiality and security of records are observed in line with statutory and regulatory
 requirements.
- Provide reports as appropriate on the health and wellbeing of employees and contribute to meeting of agreed key performance indicators (KPIs) and other service activities reporting.
- Coordinate and implement IT activity for the Unit in accordance with best IT system practice.
- Contribute to service planning and to the financial estimates process for GOHW and An Garda Síochána in general.

- Represent the service as required internally or externally.
- Demonstrate pro-active commitment to all communications with internal and external stakeholders.
- Contribute to the GOHW workforce plan at an operational and strategic level.
- Work with the Occupational Health Nursing team and Business Support team to optimise service effectiveness, skills mix and staffing requirements.

Evaluation of Service

- Undertake and participate in the evaluation and audit of practice and the effectiveness of service delivery.
- Conduct, encourage and support research activities as well as participate the development of appropriate audit systems.

NOTE: The above are not intended to be a comprehensive list of all duties involved and consequently, the appointed post holder may be required to perform other duties in line with service developments and business requirements as assigned by the CMO.

Essential Criteria

Candidates must, on or before the closing date for applications, have:

documentary evidence will be required).

- 1. a) Current registration or eligibility for registration in the Irish Medical Council's General Register of Medical Practitioners.
 - *Please note: Candidates who are successful in this competition will be required, prior to appointment, to be registered with the Irish Medical Council.

and

- b) A relevant postgraduate membership qualification in Occupational Medicine obtained by examination, e.g. Membership of the Faculty of Occupational Medicine Ireland or Membership of the Faculty of Occupational Medicine UK.

 (Where the examination has already been passed, but the qualification has not been conferred,
- Experience in medical assessment of employees to determine fitness for work subsequent to or during sickness absence and advising on workplace adjustments where applicable.
- 3. Experience working in a multi-disciplinary team, which may include medical, nursing or allied healthcare professionals.
- 4. Experience providing advice to an organisation on a wide range of occupational health issues, including complex issues.
- 5. Experience identifying areas for occupational health service improvement and implementing effective change.

Desirable Criteria

- 1. Entry on the Irish Medical Council's Register of Medical Specialists in Occupational Medicine (Candidates who can demonstrate they are working towards and expect to achieve Specialist Registration through the Specialist Registrar Training Scheme or via the alternative Specialist Division Registrar route within 2 years of appointment).
- 2. A current full driving licence without endorsement minimum category B.

In addition to the attributes and experience outlined above, the successful candidate will need to demonstrate that they possess the behaviours and competencies identified as being important for the Occupational Health Physician role.

Training and Development

GOHW is a recognised training site in Occupational Medicine, recognised by the Faculty of Occupational Medicine, RCPI.

While post holders are covered by state indemnity, they would be expected to maintain supplementary personal medical defence insurance.

Post holders will be fully supported for Irish Medical Council medical registration and Continuing Professional Development/Professional Competence Assurance.

The successful candidate will be expected, subject to properly discharging the functions of the post, to stay up to date with current occupational medicine practice. This includes actively participating in ongoing training and development opportunities and maintaining full registration and professional competence in line with current Medical Council standards.

As relevant to work and the maintenance of professional competence requirements, there will be supported opportunities to attend accredited national and international medical training and education. Occupational Physicians are also supported and encouraged to engage with professional networks such as the Faculty of Occupational Medicine & the Irish Society of Occupational Medicine.

Key Skills/Competencies for effective performance as an Occupational Health Physician

Professional and clinical knowledge

- The ability and knowledge to carry out the duties and responsibilities of the role to a high level.
- Knowledge of and familiarity with Health and Safety legislation and Employment/Disability legislation as it relates to Ireland.

Strategic planning and organisation of resources

- An understanding of strategic planning for the delivery of occupational health service.
- The ability to identify areas for service improvements and how to implement change.
- Experience in effective service planning and organising skills including awareness of resource management and importance of value for money.

Service evaluation and audit

• A knowledge of audit to evaluate and improve occupational health service delivery.

Communication and Interpersonal skills

- Ability to empathise with and treat staff and colleagues with dignity and respect.
- Ability to communicate views, opinion, and decisions in an effective manner.

Leadership & Team Working Skills

- Ability to provide leadership in the delivery of agreed service goals and targets.
- The ability to collaborate and work in co-operation with various departments/sections in achieving organisational objectives and goals.

Candidates should note that admission to the competition does not imply that they meet the eligibility criteria. Therefore, candidates should satisfy themselves that they meet the eligibility criteria for this competition



Section 4 Eligibility to Apply

Eligibility to apply and certain restrictions on eligibility

Citizenship Requirements

Eligible candidates must be:

- (a) A citizen of the European Economic Area (EEA). The EEA consists of the Member States of the European Union, Iceland, Liechtenstein and Norway; or
- (b) A citizen of the United Kingdom (UK); or
- (c) A citizen of Switzerland pursuant to the agreement between the EU and Switzerland on the free movement of persons; or
- (d) A non-EEA citizen who has a stamp 4* or a Stamp 5 permission.

*Please note that a 50 TEU visa, which is a replacement for Stamp 4EUFAM after Brexit, is acceptable as a Stamp 4 equivalent.

To qualify candidates must be eligible by the date of any job offer. It is the candidates responsibility to maintain eligibility.

Collective Agreement: Redundancy Payments to Public Servants

The Department of Public Expenditure, Infrastructure, Public Service Reform and Digitalisation letter dated 28th June 2012 to Personnel Officers introduced, with effect from 1st June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure, Infrastructure, Public Service Reform and Digitalisation and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the Public Service by any Public Service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011) for a period of 2 years from termination of the employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

Incentivised Scheme for Early Retirement (ISER)

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are not eligible to apply for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position.



Section 4 Eligibility to Apply

Department of Health and Children Circular (7/2010)

The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for re-employment in the public health sector or in the wider Public Service or in a body wholly or mainly funded from public moneys. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years. People who availed of the VER scheme are not eligible to apply in this competition. People who availed of the VRS scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

Department of Environment, Community & Local Government (Circular Letter LG(P) 06/2013)

The Department of Environment, Community & Local Government Circular Letter LG(P) 06/2013 introduced a Voluntary Redundancy Scheme for Local Authorities. In accordance with the terms of the Collective Agreement: Redundancy Payments to Public Servants dated 28 June 2012 as detailed above, it is a specific condition of that VER Scheme that persons will not be eligible for re-employment in any Public Service body [as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011 and the Public Service Pensions (Single Scheme and Other Provisions) Act 2012] for a period of 2 years from their date of departure under this Scheme. These conditions also apply in the case of engagement/employment on a contract for service basis (either as a contractor or as an employee of a contractor).

Declaration

Applicants will be required to declare whether they have previously availed of a Public Service scheme of incentivised early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.

Employer of Choice

As an Employer of Choice, An Garda Síochána has many flexible and family friendly policies e.g. Worksharing, Shorter Working Year, Remote Working (operated on a 'blended' basis), etc. All elective policies can be applied for in accordance with the relevant statutory provisions and are subject to the business needs of the organisation.



General

The appointment is to a permanent post in An Garda Síochána and is subject to the Policing, Security and Community Safety Act 2024, the Public Service Management (Recruitment and Appointments) Act 2004 and any other Act for the time being in force relating to An Garda Síochána.

Please note appointments from within An Garda Síochána for staff employed pre-commencement of the Policing Security & Community Safety Act will be to a Civil Service grade with Civil Service terms and conditions.

Salary Scale

The OCCUPATIONAL PHYSICIAN - PPC salary scale will apply to this position.

The PPC (Personal Pension Contribution) salary scale (annually) for this position, with effect from 1st August 2025 is as follows:

¹Long Service increment (LSI 1) may be payable following 3 years' satisfactory service at the maximum of scale.

²Long Service increment (LSI 2) may be payable following 6 years' satisfactory service at the maximum of scale.

IMPORTANT NOTE:

In the normal course of appointments, salary entry point will be at the first point of the scale and is subject to Government pay policy procedures. For the purposes of this competition, the appointment of suitable candidates to an increment above first point of the scale would be considered, at the discretion of the Commissioner, and in line with the possession of the specified academic/professional qualification and/or relevant professional experience required for the role.

Personal Pension Contribution

The PPC pay rate applies when the individual is required to pay a Personal Pension Contribution (otherwise known as a main scheme contribution) in accordance with the rules of their main/personal superannuation scheme. This is different to a contribution in respect of membership of a Spouses' and Children's scheme, or the Additional Superannuation Contributions (ASC).

A different rate will apply where the appointee is not required to make a Personal Pension Contribution.



Candidates should note that the rate of remuneration may be adjusted from time to time in line with Government pay policy. Increments may be awarded annually, subject to satisfactory performance.

Important Note

Different terms and conditions may apply, if, immediately prior to appointment the appointee is already a serving Civil Servant or Public Servant.

Payment will be made fortnightly in arrears by Electronic Fund Transfer (EFT) into a bank account of an employee's choice. Payment cannot be made until a bank account number and bank sort code has been supplied to the HR Directorate, Athlumney House, Johnstown, Navan, Co Meath C15 ND62. Statutory deductions from salary will be made as appropriate.

Upon appointment, you will agree that any overpayment of salary, allowances, or expenses will be repaid by you subject to An Garda Síochána's Management of Overpayments Policy.

Location

Garda Headquarters, Phoenix Park, Dublin 8.

Tenure and Probation

The appointment is to a permanent position on a probationary contract in An Garda Síochána. The probationary contract will be for a period of one year from the date specified on the contract. During the period of your probation, your performance will be subject to review by your line manager(s) to determine whether you:

- (i) Have performed in a satisfactory manner;
- (ii) Have been satisfactory in general conduct, and;
- (iii) Are suitable from the point of view of health with particular regard to sick leave.

Prior to the completion of your probation, a decision will be made as to whether or not you will be retained, subject to An Garda Síochána's Probation Policy. This decision will be based on your performance assessed against the criteria set out in (i) to (iii) above. The detail of the probationary process will be explained to you and you will be given a copy of An Garda Síochána Policy on probation.

Notwithstanding the preceding paragraphs in this section, your probation contract may be terminated at any time prior to the expiry of the term of the contract by either side in accordance with the Minimum Notice and Terms of Employment Acts, 1973 to 2005.



In the following circumstances, your probation period may be extended:

- The probationary period stands suspended when an employee is absent due to Maternity or Adoptive Leave.
- In relation to an employee absent on Parental Leave or Carers Leave, the employer may require probation to be suspended if the absence is not considered to be consistent with the continuation of the probation.
- Any other statutory provision providing that probation shall
 - (i) stand suspended during an employee's absence from work, and
 - (ii) be completed by the employee on the employee's return from work after such absence.
- Where probation is suspended, An Garda Síochána will notify you of the circumstances relating to the suspension.

All appointees will serve a one-year probationary period. If an appointee who fails to satisfy the conditions of probation, a serving member of Garda staff in An Garda Síochána immediately prior to their appointment from this competition, the issue of reversion will normally arise. In the event of reversion, an employee will return to a vacancy in their former grade.

Hours of attendance

Hours of attendance will be fixed from time to time but will amount to on average not less than 41 hours 15 minutes gross including lunch breaks, or 35 hours net per week.

The successful candidate will be required to work such additional hours from time to time as may be reasonable and necessary for the proper performance of their duties subject to the limits set down in the working time regulations.

The Organisation of Working Time Act

The terms of the Organisation of Working Time Act 1997 will apply, where appropriate, to this employment.

Headquarters

Headquarters will be such as may be designated from time to time by the Head of the Department/organisation. When required to travel on official duty the appointee will be paid appropriate travelling expenses and subsistence allowances, subject to rates to be advised per the Garda Staff Handbook.



Duties

The employee will be required to perform any duties appropriate to the position which may be assigned from time to time. The employee may not engage in private practice or be connected with any outside business which would interfere with the performance of official duties or conflict with their role.

Annual Leave

Your annual leave allowance will be 30 working days a year. This allowance, which is subject to the usual conditions regarding the granting of annual leave, is on the basis of a five-day week and is exclusive of the usual public holidays.

Sick Leave

Pay during properly certified sick leave will apply in accordance with the provisions of An Garda Síochána Sick Leave Policy. Where an employee is eligible for Illness Benefit (IB), they must comply with the procedures for claiming IB from the Department of Social Protection and must confirm that they have mandated the IB payment directly to An Garda Síochána. Failure to do so may result in an overpayment.

Superannuation and Retirement

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in An Garda Síochána at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered an appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at www.singlepensionscheme.gov.ie.

Where the appointee has worked in a pensionable (non-Single Scheme terms) public service job in the 26 weeks prior to appointment or is currently on a career break or special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history.

Key provisions attaching to membership of the Single Scheme are as follows:

- Pensionable Age: The minimum age at which pension is payable is the same as the age of eligibility for the State Pension, currently 66.
- Retirement Age: Scheme members must retire on reaching the age of 70.
- Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are up-rated each year by reference to CPI).
- Post retirement pension increases are linked to CPI.



Pension Abatement

If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during their re-employment that pension **will be subject** to abatement in accordance with Section 52 of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012. **Please note: In applying for this position you are acknowledging that you understand that the abatement provisions, where relevant, will apply. It is not envisaged that An Garda Síochána will support an application for an abatement waiver in respect of appointments to this position.**

However, if the appointee was previously employed in the Civil or Public Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER), the Department of Health Circular 7/2010 VER/VRS or the Department of Environment, Community & Local Government Circular letter LG(P) 06/2013, any of which renders a person ineligible for the competition) the entitlement to that pension will cease with effect from the date of reappointment. Special arrangements may, however be made for the reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.

Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease.

Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

Ill-Health Retirement

Please note any person who previously retired on ill-health grounds under the terms of a superannuation scheme are required to declare, at the initial application phase, that they are in receipt of such a pension to the organisation administering the recruitment competition.

Applicants will be required to attend the Chief Medical Officer's office to assess their ability to provide regular and effective service taking account of the condition, which qualified them for IHR.



Appointment post Ill-health retirement from Civil Service:

If successful in their application through the competition, the applicant should to be aware of the following:

- If deemed fit to provide regular and effective service and assigned to a post, their civil service ill-health pension ceases.
- If the applicant subsequently fails to complete probation or decides to leave their assigned post, there can be no reversion to the civil service IHR status, nor reinstatement of the civil service IHR pension, that existed prior to the application nor is there an entitlement to it.
- The applicant will become a member of the Single Public Service Pension Scheme (SPSPS) upon appointment if they have had a break in pensionable public/civil service of more than 26 weeks.

Appointment post III-health retirement from Public Service:

Where an individual has retired from a Public Service body their ill-health pension from that employment may be subject to review in accordance with the rules of ill-health retirement under that scheme.

General Information

An Garda Síochána/Staffline Recruitment Ireland will not be responsible for refunding any expenses incurred by candidates. Posts will be offered in sequence to those candidates who finish highest in the overall order of merit drawn up following the interviews, i.e. the highest ranking candidates will, in turn, be offered a post.
