Section 1

An Overview of An Garda Síochána

An Garda Síochána is the national police and security service of Ireland, comprised of approximately 14,000 Garda Members, 3,400 Garda Staff and 350 Garda Reserves. An Garda Síochána is a community focused organisation with a mission of 'Keeping People Safe'. With a dual role and responsibility for the provision of policing services, and protecting the security of the State, An Garda Síochána is committed to delivering a responsive, effective and efficient service, that meet the needs of our communities.

The organisation was established over 100 years ago at the inception of the state, and has a proud history of delivering community policing. In order to build upon this strong foundation, An Garda Síochána must continue to evolve, responding as a modern police and security service to the changing face of crime, vulnerability, population and citizen expectation.

An Garda Síochána is charged with delivering on the key commitments made within the Programme for Government. In support of such, the organisation is growing at scale, with the effective use of Garda resources and capabilities as a key focus area.

An Garda Síochána has delivered on a significant organisational transformation programme including the introduction of cutting-edge technology, new methods of working and the biggest change to its structure in its history.

The introduction of a Garda Board is supporting the organisation in becoming more agile and adaptive, while a new Policing and Community Safety Authority is supporting the effective provision and continuous improvement of policing services. These developments and more mean it is a particularly exciting time to join An Garda Síochána and the organisation is determined to recruit the best talent to help deliver its ambitious programme of work.

Strategy and Transformation (S&T) enables the organisation to plan and implement major reform, including the [A Policing Service For Our Future \(APSFF\)](#) programme to implement the recommendations of the [Commission on the Future of Policing in Ireland \(CoFPI\)](#), the largest transformation in An Garda Síochána (AGS) since its foundation.

S&T is a key enabler to support AGS in delivering organisation wide change and transformation, strategic reform, innovation and improvements. This includes strategic planning, prioritisation, portfolio management and change delivery, benefits realisation and ongoing improvement and innovation. In addition, the function is responsible for developing and maintaining exemplary external and internal stakeholder relations for AGS through the provision of timely, professional and consistent information and communications.

S&T plays a key role in two strategic drivers, in particular:

- Delivering CoFPI's principle for AGS to be 'adaptive, innovative and cost-efficient'.
- Enabling 'sustainable change and innovation' as per the fifth pillar of the [2022 - 2024 Strategy Statement](#).

Following a recent review and benchmarking exercise, S&T is moving to a structure based on four functional areas or 'pillars':

- Strategy, Planning & Prioritisation (SP&P) responsible for delivering strategic planning and policy thinking, and aligning them to key priorities of the organisation. This includes developing and agreeing on the Annual Service Plan and 3-Year Strategy Statement.
- Transformation Delivery (TD) responsible for deploying expert programme / project management, change management and process transformation resources to drive the end-to-end delivery of major programmes / projects.
- Portfolio Management & Reporting (PM&R) responsible for the governance and oversight of programmes and projects accepted into the S&T transformation portfolio. This includes developing and maintaining the portfolio plan, and managing at a portfolio level the dependencies, risks and issues, and change impact across the portfolio.
- Innovation & Continuous Improvement (I&CI) responsible for tracking and facilitating post-programme benefits realisation, supporting change and process improvement throughout AGS, and working throughout the organisation to activate innovative initiatives.

This role will be Transformation Delivery Lead (Principal Officer level) within the Strategy and Transformation function.

Transformation Delivery (TD) will provide a change and transformation delivery centre of excellence for AGS, deploying expert programme / project management, business process analysis and change management resources for the end-to-end delivery of the major programmes/projects within the transformation portfolio. Multi-disciplinary teams will be deployed to major programmes, comprising project management, change management and business process analyst expertise, while individual resources may be deployed to provide support and expertise for smaller scale projects.

The three pillars within the Transform Delivery team are:

- **Project Management Team**, responsible for the provision of expert resources to transformation projects and programmes to manage successful end-to-end delivery, using a consistent best practice approach, complete project / programme reporting, and transfer skills and knowledge to colleagues managing business as usual activities.
- **Change Management Team**, responsible for providing change management expertise for programmes and projects, including defining and developing change impact assessments for each programme; developing a plan for the delivery of appropriate change management activities; providing expert resources to proactively prepare stakeholders for the impact of the changes being delivered by transformation projects and programmes.
- **Business Process Analysis Team**, responsible for analysing and reviewing processes as part of S&T services. The completion of impact assessments for current processes will help shape designs for the future and make informed decisions with key stakeholders.

This role will report directly to the Director for Transformation Delivery (TD). The successful applicant will play a key role in working with the Director for TD in the leadership and management of the three pillars across the function.

Responsibilities

The person undertaking this role will be responsible for:

- Leadership and management of personnel in the Transformation Delivery pillar, providing direction and cohesion to resources across all its specialist teams, as agreed with Director for Transformation Delivery.
- Support the development and embedding of Transformation delivery and change management best practice, along with an integrated approach to support ongoing transformation and reform across the organisation.

- Manage and guide expert delivery resources (specialist programme/project, change management and business process analyst resources), and multi-disciplinary teams, to deliver programmes and projects within the transformation portfolio in line with stakeholder expectations and to time, cost and quality, as agreed with Director of Transformation Delivery.
- Manage and guide personnel within the Change Management team, ensuring that required support to programmes/projects to assess and successfully embed change are provided.
- Manage and guide personnel within the Business Process Analysis team, ensuring that agreed personnel are working effectively with their key programme/project stakeholders and providing the required level of business analytics expertise to support delivery of expected outcomes.
- Engage and liaise with senior stakeholders across the organisation to build consensus and ensure delivery of results and expected benefits. Work across enabling functions to ensure alignment and orientation towards expected outcomes.
- Act as a senior point of contact for key programme/project stakeholders to provide guidance and recommendations to address critical risks and issues.
- Supporting the Director for TD in the establishment and maintenance of appropriate structures, controls and governance, to enable the reporting on performance and provision of sufficient metrics and reporting to allow analysis of performance against organisational requirements and intended outcomes.
- Provision of a quality Transformation Delivery service for agreed projects and programmes, and providing assurance on this to the Director for TD.
- Monitor resource utilisation across Transformation Delivery to support decision making on resource allocation and prioritisation.
- Support the ongoing development of appropriate programme/project management, change management, and business analysis capabilities consistently across the team by an ongoing focus on professional development and keeping up to date with best practices and actively seeking to continually improve delivery.
- Ensure that monthly information is provided to the Director for TD to enable effective financial management and planning.
- Carry out such other duties and responsibilities as are assigned from time to time.
- Lead required HR aspects regarding the day-to-day running of the teams, ensuring full compliance with employment legislation, and An Garda Síochána HR policy, overseeing recruitment, training, and performance of staff, as agreed with Director for TD.

Essential Criteria

Applicants must, as at the closing date for receipt of applications, have:

Qualification

A qualification at minimum level 8 in the National Framework of Qualifications (Honours Bachelor Degree level).

Experience

Applicants must, as at the closing date for receipt of application forms, be able to demonstrate by providing personal and specific examples on their application form that they have a minimum of 5 years' experience in a dedicated transformation delivery project, programme or portfolio leadership role.

Experience must include:

- Successfully demonstrates experience in designing, implementing and delivering complex, large scale transformation programmes, valued at several million Euros.
- Strong track record and demonstrable experience in the leading of multi-disciplinary specialist programme / project delivery function, along with effective decision making to manage competing priorities and demands to deliver major programmes and projects to time, cost and quality and expected benefits.
- Comprehensive experience in developing strong, collaborative working relationships, with a proven demonstrated ability to manage senior level connections across the organisation, as well as key internal/external stakeholders and partner agencies.
- Highly developed skills in priority setting and alignment of project priorities and approach to organisational strategy and vision, in order to derive expected benefits.
- Excellent interpersonal and communication skills with a proven ability to analyse and synthesise large amounts of information (qualitative and quantitative) and present required information clearly and concisely to a wide audience, both verbally and in written communication, to enable informed decision making.
- Proven experience of working well with others under pressure, to proactively problem solve, make sound and well-informed decisions and orientate the group towards delivery of workable solutions.
- Programme and project management methodologies (PMP, PgMP, PRINCE2) or project management frameworks (Agile, Sigma, Lean or PRINCE2, Scrum, Kanban, or SAFe), alongside change management strategies and principles.
- Providing leadership and motivation to large multi-disciplinary teams (at least 10 to 15+ people) and managing them in accordance with the principles of performance management and personal development.

Desirable Criteria

Experience in one or more of the following contexts:

- A dedicated transformation leadership role in more than one organisation, or experience outside of the Public or Civil Service, or international experience (e.g. working abroad or significant engagement with international organisations and processes)
- Relevant certification or qualification (e.g. Higher Diploma, Masters) in project management (PMP, PRINCE2, Scrum, SAFe etc.) or Change Management (e.g., PROSCI, Change Management Institute, Kotter, ADKAR).

Key Skills/Competencies for effective performance in this role

- Leads the team, setting high standards, tackling any performance problems & facilitating high performance.
- Facilitates an open exchange of ideas and fosters an atmosphere of open communication.
- Contributes to the shaping of Departmental / Government strategy and policy.

- Develops a culture of learning & development, offering coaching and constructive / supportive feedback.
- Leads on preparing for and implementing significant change and reform.
- Anticipates and responds quickly to developments in the sector / broader environment.

Candidates should note that admission to the competition does not imply that they meet the eligibility criteria. Therefore, candidates should satisfy themselves that they meet the eligibility criteria for this competition

Eligibility to Apply

Eligibility to apply and certain restrictions on eligibility

Citizenship Requirements

Eligible candidates must be:

- (a) A citizen of the European Economic Area (EEA). The EEA consists of the Member States of the European Union, Iceland, Liechtenstein and Norway; or
- (b) A citizen of the United Kingdom (UK); or
- (c) A citizen of Switzerland pursuant to the agreement between the EU and Switzerland on the free movement of persons; or
- (d) A non-EEA citizen who has a stamp 4* or a Stamp 5 permission.

**Please note that a 50 TEU visa, which is a replacement for Stamp 4EUFAM after Brexit, is acceptable as a Stamp 4 equivalent.*

To qualify candidates must be eligible by the date of any job offer. It is the candidates responsibility to maintain eligibility.

Collective Agreement: Redundancy Payments to Public Servants

The Department of Public Expenditure, Infrastructure, Public Service Reform and Digitalisation letter dated 28th June 2012 to Personnel Officers introduced, with effect from 1st June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure, Infrastructure, Public Service Reform and Digitalisation and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the Public Service by any Public Service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011) for a period of 2 years from termination of the employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

Incentivised Scheme for Early Retirement (ISER)

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are not eligible to apply for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position.

Eligibility to Apply

Department of Health and Children Circular (7/2010)

The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for re-employment in the public health sector or in the wider Public Service or in a body wholly or mainly funded from public moneys. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years. People who availed of the VER scheme are not eligible to apply in this competition. People who availed of the VRS scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

Department of Environment, Community & Local Government (Circular Letter LG(P) 06/2013)

The Department of Environment, Community & Local Government Circular Letter LG(P) 06/2013 introduced a Voluntary Redundancy Scheme for Local Authorities. In accordance with the terms of the Collective Agreement: Redundancy Payments to Public Servants dated 28 June 2012 as detailed above, it is a specific condition of that VER Scheme that persons will not be eligible for re-employment in any Public Service body [as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011 and the Public Service Pensions (Single Scheme and Other Provisions) Act 2012] for a period of 2 years from their date of departure under this Scheme. These conditions also apply in the case of engagement/employment on a contract for service basis (either as a contractor or as an employee of a contractor).

Declaration

Applicants will be required to declare whether they have previously availed of a Public Service scheme of incentivised early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.

Employer of Choice

As an Employer of Choice, An Garda Síochána has many flexible and family friendly policies e.g. Worksharing, Shorter Working Year, Remote Working (operated on a 'blended' basis), etc. All elective policies can be applied for in accordance with the relevant statutory provisions and are subject to the business needs of the organisation.

General

The appointment is to a permanent post in An Garda Síochána and is subject to the Policing, Security and Community Safety Act 2024, the Public Service Management (Recruitment and Appointments) Act 2004 and any other Act for the time being in force relating to An Garda Síochána.

Please note appointments from within An Garda Síochána for staff employed pre-commencement of the Policing Security & Community Safety Act will be to a Civil Service grade with Civil Service terms and conditions.

Salary Scale

The Principal Officer salary scale will apply to this position.

The PPC (Personal Pension Contribution) salary scale (annually) for this position is as below:

From 1st March 2025 as follows:

€104,971 - €109,426 - €113,845 - €118,298 - €122,054 - €125,951* - €129,841**

From 1st August 2025 as follows:

€106,021 - €110,520 - €114,983 - €119,481 - €123,275 - €127,211* - €131,139**

**Long Service increment (LSI 1) may be payable following 3 years' satisfactory service at the maximum of scale.*

***Long Service increment (LSI 2) may be payable following 6 years' satisfactory service at the maximum of scale.*

Personal Pension Contribution

The PPC pay rate applies when the individual is required to pay a Personal Pension Contribution (otherwise known as a main scheme contribution) in accordance with the rules of their main/personal superannuation scheme. This is different to a contribution in respect of membership of a Spouses' and Children's scheme, or the Additional Superannuation Contributions (ASC).

A different rate will apply where the appointee is not required to make a Personal Pension Contribution.

Candidates should note that entry will be at the minimum of the scale and will not be subject to negotiation and the rate of remuneration may be adjusted from time to time in line with Government pay policy. Increments may be awarded annually, subject to satisfactory performance

Important Note

Different terms and conditions may apply, if, immediately prior to appointment the appointee is already a serving Civil Servant or Public Servant.

Payment will be made fortnightly in arrears by Electronic Fund Transfer (EFT) into a bank account of an employee's choice. Payment cannot be made until a bank account number and bank sort code has been supplied to the HR Directorate, Athlumney House, Johnstown, Navan, Co Meath C15 ND62. Statutory deductions from salary will be made as appropriate.

Upon appointment, you will agree that any overpayment of salary, allowances, or expenses will be repaid by you subject to An Garda Síochána's Management of Overpayments Policy.

Location

This position will be based in Dublin, primarily in Ashtown Gate however travel will be required to other locations to meet some requirements of the role.

Tenure and Probation

The appointment is to a permanent position on a probationary contract in An Garda Síochána. The probationary contract will be for a period of one year from the date specified on the contract. During the period of your probation, your performance will be subject to review by your line manager(s) to determine whether you:

- (i) Have performed in a satisfactory manner;
- (ii) Have been satisfactory in general conduct, and;
- (iii) Are suitable from the point of view of health with particular regard to sick leave.

Prior to the completion of your probation, a decision will be made as to whether or not you will be retained, subject to An Garda Síochána's Probation Policy. This decision will be based on your performance assessed against the criteria set out in (i) to (iii) above. The detail of the probationary process will be explained to you and you will be given a copy of An Garda Síochána Policy on probation.

Notwithstanding the preceding paragraphs in this section, your probation contract may be terminated at any time prior to the expiry of the term of the contract by either side in accordance with the Minimum Notice and Terms of Employment Acts, 1973 to 2005.

In the following circumstances, your probation period may be extended:

- The probationary period stands suspended when an employee is absent due to Maternity or Adoptive Leave.
- In relation to an employee absent on Parental Leave or Carers Leave, the employer may require probation to be suspended if the absence is not considered to be consistent with the continuation of the probation.
- Any other statutory provision providing that probation shall
 - (i) stand suspended during an employee's absence from work, and
 - (ii) be completed by the employee on the employee's return from work after such absence.
- Where probation is suspended, An Garda Síochána will notify you of the circumstances relating to the suspension.

All appointees will serve a one-year probationary period. If an appointee who fails to satisfy the conditions of probation, a serving member of Garda staff in An Garda Síochána immediately prior to their appointment from this competition, the issue of reversion will normally arise. In the event of reversion, an employee will return to a vacancy in their former grade.

Hours of attendance

Hours of attendance will be fixed from time to time but will amount to on average not less than 41 hours 15 minutes gross including lunch breaks, or 35 hours net per week.

The successful candidate will be required to work such additional hours from time to time as may be reasonable and necessary for the proper performance of their duties subject to the limits set down in the working time regulations.

The Organisation of Working Time Act

The terms of the Organisation of Working Time Act 1997 will apply, where appropriate, to this employment.

Headquarters

Headquarters will be such as may be designated from time to time by the Head of the Department/organisation. When required to travel on official duty the appointee will be paid appropriate travelling expenses and subsistence allowances, subject to rates to be advised per the Garda Staff Handbook.

Duties

The employee will be required to perform any duties appropriate to the position which may be assigned from time to time. The employee may not engage in private practice or be connected with any outside business which would interfere with the performance of official duties or conflict with their role.

Annual Leave

Your annual leave allowance will be 30 days. This allowance, which is subject to the usual conditions regarding the granting of annual leave, is on the basis of a five-day week and is exclusive of the usual public holidays.

Sick Leave

Pay during properly certified sick leave will apply in accordance with the provisions of An Garda Síochána Sick Leave Policy. Where an employee is eligible for Illness Benefit (IB), they must comply with the procedures for claiming IB from the Department of Social Protection and must confirm that they have mandated the IB payment directly to An Garda Síochána. Failure to do so may result in an overpayment.

Superannuation and Retirement

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in An Garda Síochána at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered an appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at www.singlepensionscheme.gov.ie.

Where the appointee has worked in a pensionable (non-Single Scheme terms) public service job in the 26 weeks prior to appointment or is currently on a career break or special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history.

Key provisions attaching to membership of the Single Scheme are as follows:

- Pensionable Age: The minimum age at which pension is payable is the same as the age of eligibility for the State Pension, currently 66.
- Retirement Age: Scheme members must retire on reaching the age of 70.
- Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are up-rated each year by reference to CPI).
- Post retirement pension increases are linked to CPI.

Pension Abatement

If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during their re-employment that pension **will be subject** to abatement in accordance with Section 52 of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012. **Please note: In applying for this position you are acknowledging that you understand that the abatement provisions, where relevant, will apply. It is not envisaged that An Garda Síochána will support an application for an abatement waiver in respect of appointments to this position.**

However, if the appointee was previously employed in the Civil or Public Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER), the Department of Health Circular 7/2010 VER/VRS or the Department of Environment, Community & Local Government Circular letter LG(P) 06/2013, any of which renders a person ineligible for the competition) the entitlement to that pension will cease with effect from the date of reappointment. Special arrangements may, however be made for the reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.

Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease.

Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

Ill-Health Retirement

Please note any person who previously retired on ill-health grounds under the terms of a superannuation scheme are required to declare, at the initial application phase, that they are in receipt of such a pension to the organisation administering the recruitment competition.

Applicants will be required to attend the Chief Medical Officer's office to assess their ability to provide regular and effective service taking account of the condition, which qualified them for IHR.

Appointment post Ill-health retirement from Civil Service:

If successful in their application through the competition, the applicant should be aware of the following:

- If deemed fit to provide regular and effective service and assigned to a post, their civil service ill-health pension ceases.

Where an individual has retired from a Public Service body their ill-health pension from that employment may be subject to review in accordance with the rules of ill-health retirement under that scheme.

If an applicant is successful, on appointment the applicant will be required to declare whether they are in receipt of a Public Service Pension (ill-health or otherwise) and their Public Service Pension may be subject to abatement.

The applicant will become a member of the Single Public Service Pension Scheme (SPSPS) upon appointment if they have had a break in pensionable public/civil service of more than 26 weeks.

Pension Accrual

A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one pre-existing public service pension scheme (i.e. non-Single Scheme) as per the 2012 Act shall apply. This 40-year limit is provided for in the Public Service Pensions (Single Scheme and Other Provisions) Act 2012. This may have implications for any appointee who has acquired pension rights in a previous public service employment.

General Information

An Garda Síochána/Staffline Recruitment Ireland will not be responsible for refunding any expenses incurred by candidates. Posts will be offered in sequence to those candidates who finish highest in the overall order of merit drawn up following the interviews, i.e. the highest ranking candidates will, in turn, be offered a post. Specific candidate criteria

Any person wishing to use such equipment for any of these purposes must seek written permission in advance. This policy is in place to protect the privacy of staff and customers and the integrity of our assessment material and assessment processes. Unsanctioned use of recording equipment by any person is a breach of this policy. Any candidate involved in such a breach could be disqualified from the competition and could be subject to prosecution under section 55 of the Public Service Management (Recruitment & Appointments) Act, 2004.

Code of Practice

- The original decision was made appropriately.

A candidate who is simply seeking clarification on the basis for the decision reached about their candidature should obtain this feedback from the office holder in charge of the recruitment process.

They do not need to invoke any of the procedures referred to above.

In accordance with the principles of the above Code of Practice, An Garda Síochána and Staffline Recruitment Ireland are committed to providing clear, specific and meaningful feedback to candidates. In this regard, written feedback will be provided to candidates. This will consist of the candidate's marks from the competition and comments from the interview board on the candidate's performance, as appropriate.
