## **Clare Garda Youth Awards 2024**

**Clare Gardai in association with The Shannon Airport Group present their Garda Youth Awards, celebrating outstanding young people between the ages of 13 and 21 years.**

**Clare Gardai and The Shannon Airport Group recognise that a lot of good work is being done by young people throughout the community.**

**Awards will be considered or nominated young people who by their presence make the communities a better place to live in or have shown great determination in their own lives. Groups of two or more young people whose combined efforts have contributed positively to their communities will also be considered. All nominees and group members should be between the ages of 13 and 21 years. As much information as possible should be supplied by nominators in respect of nominees and why you think they deserve an award. A seconder is required for each nominee.**



## **RULES**

- 1. Awards are confined to those young people who are aged between 13 and 21 years as of 17<sup>th</sup> October 2024.**
- 2. Permanent residence of the young person must be in the Clare Garda District.**
- 3. Awards are confined to individuals and groups of two or more people.**
- 4. The judging panel will decide upon one nominee in each category to go forward to represent the District at the National Garda Youth Awards. The judging panel will consist of six members chaired by a member of An Garda Síochána not below the rank of Inspector.**
- 5. Any member of the public may nominate anyone whom they feel deserves an award.**
- 6. Nominations may be submitted by family members or relatives.**
- 7. Previous award winners are not eligible.**
- 8. Forms must be completed by a nominator and co-nominator.**
- 9. Shannon Group and An Garda Síochána have permission to use the entrants/winners imagery on their Shannon Group digital channels.**
- 10. The closing date for all entries is the 10<sup>th</sup> May 2024.**
