These awards celebrate outstanding young people between 13 and 21 years of age and recognise the good work being done by young people throughout the communities of Dublin South Central.

Awards will be considered for nominated young people who by their presence make their communities a better place to live.

There will also be an award for groups of two or more young people whose combined efforts have contributed positively to their communities. All nominees and group members should be between 13 and 21 years of age. The Dublin South Central Garda Division covers Kevin Street, Pearse Street, Kilmainham and Donnybrook and Irishtown Garda Stations.

As much information as possible should be supplied by nominators in respect of nominees and why you think they deserve an award. Additional space is provided on the reverse of the form. A seconder is required for each nominee.

1. Awards are confined to those young people who are aged between 13 and 21 years of age on *31st August 2020*.
2. Permanent residence of the young person must be in the Garda Division in which they are nominated.
3. Awards are confined to individuals and groups of two or more people.
4. Judge's decision is final.
5. The Judging Panel will decide upon one nominee in each category to go forward to represent the Division at the National Garda Youth Awards.
6. Any member of the public may nominate anyone whom they feel deserves an award.
7. Nominations may be submitted by family members or relatives.
8. Previous award winners are not eligible.
9. Forms must be signed by a nominator and co-nominator.
