- 2. Permanent residence of the young person must be in the Garda Division in which they are nominated.
- 3. Awards are confined to individuals and groups of two or more people.
- 4. Judge's decision is final.
- 5. The Judging Panel will decide upon one nominee in each category to go forward to represent the Division at the National Garda Youth Awards.
- 6. Any member of the public may nominate anyone whom they feel deserves an award.
- 7. Nominations may be submitted by family members or relatives.
- 8. Previous award winners are not eligible.
- 9. Forms must be signed by a nominator and co-nominator.
