## Re: Freedom of Information Request FOI-000457-2017 Request Refused

*Dear*

I refer to your request, dated and received on 18<sup>th</sup> October, 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency “*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

*THE AMOUNT OF SPEEDING FINES THAT ISSUED IN 2016. THE AMOUNT OF SPEEDING FINES THAT WERE APPEALED AND OVERTURNED IN 2016.*

I wish to inform you that I have decided to refuse your request on the 24<sup>th</sup> October, 2017.

The purpose of this letter is to explain my decision.

### 1. Findings, particulars and reasons for decision

Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a public body for the purposes of the FOI

Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of the FOI Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the FOI Act does not apply and no right of access exists.

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term “administrative records” is understood to mean records relating to the processes of running and managing a business or organisation. As a result, the FOI Act excludes operational policing business as opposed to the defined administrative processes of An Garda Síochána.

The records sought by you relate to operational policing matters, as opposed to administrative matters relating to human resources, or finance or procurement.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the Act.

However, I advise that the that information regarding the number of Fixed Charge Notices issued for speeding on a monthly basis for the year 2016 are available on the Garda Website at the following link.

The making of a late appeal may be permitted in appropriate circumstances.
