Re: Freedom of Information Request FOI-000485-2017 Request Refused

Dear

I refer to your request, dated 27th October, 2017 and received on 31st October, 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency “*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

the scale of domestic violence statistics at a police level and the number of prosecutions. (2) crimes involving social media. (3) How often kidnaps were reported and what the motives were. (4) In relation to weapons the number of guns which police had taken off the streets/ number of gun licences and who owns them. (5) location of knife attacks. (6) crime on buses. (7) The estimated number of human trafficking victims in Ireland. And in conclusion in relation to alcohol and drugs- women committing violent crimes while under the influence of a substance/ drink cited in most crimes and the number of accused individuals for sexual assault and the number of individuals that were prosecuted.

I wish to inform you that I have decided to refuse your request on the 1st November, 2017.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a public body for the purposes of the FOI Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of the FOI Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the FOI Act does not apply and no right of access exists.

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term “administrative records” is understood to mean records relating to the processes of running and managing a business or organisation. As a result, the FOI Act excludes operational policing business as opposed to the defined administrative processes of An Garda Síochána.

The records that you sought relate to operational policing matters carried out by An Garda Síochána, as opposed to administrative matters relating to human resources, or finance or procurement.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the Act.

However, in respect of your request I wish to advise that the Central Statistics Office (CSO) publishes official statistics relating to crime in Ireland among which there maybe material relevant to your request. This information is available to the public free of charge on the CSO website:

2. Right of Appeal

The making of a late appeal may be permitted in appropriate circumstances.
