Dear

I refer to your request, dated 17th January 2018 and received on 18th January 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- copies of all correspondence between AGS and BMW regarding a trial of electric vehicles using cars supplied by the company.

I wish to inform you that I have decided to refuse your request on the 14th February, 2018.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

The details of your request were forwarded to the relevant area of An Garda Síochána in order to identify and retrieve any records related to your request. Records have been provided by the Fleet Management Section and have been reviewed by this Office. As a result of this review, I have decided to refuse your request as the records identified do not meet the criteria of administrative records as defined in the FOI Act.

Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a public body for the purposes of the FOI Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of the FOI Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the FOI Act does not apply and no right of access exists.

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term "administrative records" is understood to mean records relating to the processes of running and managing a business or organisation. As a result, the FOI Act excludes operational policing business as opposed to the defined administrative processes of An Garda Síochána.

The records that you seek do not relate to administrative matters relating to human resources, or finance or procurement. I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the Act. I have attached a Schedule of Records outlining my decision.

2. Right of Appeal

The making of a late appeal may be permitted in appropriate circumstances.
