Re: Freedom of Information Request FOI-000036-2018 Decision Refused

I refer to your request, dated 18th January, 2018 and received on 19th January, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- *A complete list of all items sold at garda auctions in 2017 - can this list please include a detailed description of the item, how much it was sold for, where it was sold, how long it was in gardai possession, and why it was taken into gardai possession*
- *A complete list of all items sold at garda auctions in 2016 - can this list please include a detailed description of the item, how much it was sold for, where it was sold, how long it was in gardai possession, and why it was taken into gardai possession*
- *A complete list of all items sold at garda auctions in 2015 - can this list please include a detailed description of the item, how much it was sold for, where it was sold, how long it was in gardai possession, and why it was taken into gardai possession*

1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance Section within An Garda Síochána who conducted a search for records relating to your request.

I wish to advise that I have made a decision to refuse your request on the 14th February, 2017

There is no specific financial item code in existence on the Financial Management System (FMS) within the Finance Section of An Garda Síochána specifically relating to receipts for items sold at Garda Auctions. In addition, there is no central recording mechanism outlining the breakdown of items sold at garda auction. These breakdowns are held manually in each garda district. In order to obtain this information, would require contacting each district which would create a significant amount of additional work and cause a disproportionate disruption of the workload. It is therefore not possible to identify the amount of money received from the auctions of such items. To provide an analysis and breakdown in relation to this part of your request would prove voluminous by reason of the nature and volume of the records involved.

Therefore, I am refusing your request under Section 15(1)(c) of the FOI Act wherein it states:

"Refusal on administrative grounds to grant FOI requests

15. (1) A head to whom an FOI request is made may refuse to grant the request where—

(c) in the opinion of the head, granting the request would, by reason of the number or nature of the records concerned or the nature of the information concerned, require the retrieval and examination of such number of records

or an examination of such kind of the records concerned as to cause a substantial and unreasonable interference with or disruption of work (including disruption of work in a particular functional area) of the FOI body concerned,"

However, in order to assist you with your request, details of receipts relating to the 'Proceeds of sales of used vehicles, old stores, forfeited and unclaimed property' have been supplied by the Finance Division of An Garda Síochána, I can inform you that receipts totaling €108,727 for 2015, €41,321 for 2016 and €90,223 for 2017 relate to the 'Proceeds of sales of used vehicles, old stores, forfeited and unclaimed property'. The income received from the proceeds of these sales is returned to the Exchequer each year.

2. Right of Appeal

In the event that you are not happy with this decision you may seek an internal review of the matter by writing to the address below and quoting reference number **FOI-00036-2017**.

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
