I refer to your request, dated and received on 11th May, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Material to show the cost of policing in Cork City, Cork North and Cork West in 2017, with a breakdown of each district in each of the three divisions, and showing the different elements which have accrued the overall costs.

I wish to inform you that I have decided to grant your request on the 7th June, 2018.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance Section of An Garda Síochána who have briefed this office and provided details of the cost of policing associated with each District in the Cork City, Cork North and Cork West Garda Divisions. Having reviewed these records, I have decided to grant your request.

An Garda Síochána operate on a Divisional basis. Each Division is commanded by a Chief Superintendent (Divisional Officer) who has responsibility for the policing of his/her Division, defined by its operational needs. Each Division is broken down into Districts and each District is commanded by a Superintendent (District Officer).

I advise that the policing costs incurred by each District in the three Cork Divisions in 2017 is detailed in **Appendix 1, 2** and 3 which are attached. Please note that the cost provided is the net cost of policing in the Division. The net cost of policing is the gross cost (expenditure) adjusted to take into account Appropriations-In-Aid (receipts).

The categories inclusive in the policing costs of each Division are listed below as requested and are provided to the Comptroller and Auditor General for the publication of the appropriation accounts:

- · Salaries, Wages and Allowances
- Travel and Subsistence
- Training, Development and Incidental Expenses
- Postal and Telecommunications Services
- Office Equipment and External IT Services
- Maintenance of Garda Premises
- Station Services
- Garda Reserve Force
- Transport
- Communications and Other Equipment
- Witnesses Expenses
- Compensation
- Appropriations in Aid
