Re: Freedom of Information Request FOI-000217-2018 Request Refused

Dear

I refer to your request, dated and received on 14th May, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána. I further refer to clarification of your request received at this Office on 1st June, 2018.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- 1) The cost for the specific ANPR cameras installed at the border between newry-Louth to date.*
- 2) Records of the number of individuals employed to install the ANPR cameras at the border.*
- 3) a copy of the contract between the 3rd party procured to install the ANPR cameras, and if not including in the contract, documentation, relating which would have advised the 3rd party the specific places where they were contracted to install the*

permanent-fixed cameras. This last relates to ALL permanently-fixed cameras in the State.

I wish to inform you that I have decided to refuse your request on the 19th June, 2018.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance, Procurement and Roads Policing and Major Event Management Sections of An Garda Síochána in order to identify and conduct a search for the records you have requested.

As a result of this search, it has been established that the specific records relating to Parts 1, 2 and 3 of your request as outlined below do not exist.

1) The cost for the specific ANPR cameras installed at the border between Newry-Louth to date.

2) Records of the number of individuals employed to install the ANPR cameras at the border.

3) a copy of the contract between the 3rd party procured to install the ANPR cameras, and if not including in the contract, documentation, relating which would have advised the 3rd party the specific places where they were contracted to install the permanent-fixed cameras. This last relates to ALL permanently-fixed cameras in the State.

In accordance with the requirements of Section 15(1)(a) of the FOI Act, I am satisfied that all reasonable steps have been taken to identify and locate the requested records.

I am therefore refusing Parts 1, 2 and 3 of your request under Section 15(1)(a) of the FOI Act which states:

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where -*
- (a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken,*

2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number **FOI-000217-2018**.

The making of a late appeal may be permitted in appropriate circumstances.
