I refer to your request, dated 7th June, 2018 and received on 11th June, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána. I also refer to further email correspondence dated 12th, 13th, and 19th June 2018 in which your request was narrowed in order to reduce the rate of fees charged.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your original request sought:

The lowest score and the highest score of successful candidates from each Garda Region in the 2012 promotion competition from Garda to Sergeant. The list of successful candidates in this competition was published on February 19th 2013. (NOTE: This is solely a request for qualifying scores. It is not a request for any personal information)

Your narrowed request:

As a result of this information you have supplied I would like to amend my freedom of information request to be limited to the Garda Interview Regional Boards DMR 3 and DMR 4.

I wish to inform you that I have decided to grant your request on 2nd July, 2018.

The purpose of this letter is to explain my decision.
