I refer to your request, dated 17th June, 2018 and received on 19th June, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

The amount An Garda Siochana spent on medical services for prisoners in garda custody in (i) the Sligo/Leitrim division and (ii) the Roscommon/Galway division in (a) 2016 (b) 2017 & (c) so far in 2018.

I wish to inform you that I have decided to grant your request on the 2nd July, 2018.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance Directorate within An Garda Síochána who conducted a search for records relating to your request. The Directorate have briefed this office and provided details of "The amount An Garda Siochana spent on medical services for

prisoners in garda custody in (i) the Sligo /Leitrim division and (ii) the Roscommon/Galway division in (a)2016 (b)2017 & (c so far in 2018.".

Having reviewed these records, I have decided to grant your request, the details of which are provided below. Within your request you seek details for the "Roscommon/Galway division". As this is not a designated Garda Division details relating to both the Roscommon/Longford Division and Galway Division are provided.

Please note that the Department of Finance advise on the scale of fees payable to medical practitioners for medical services carried out at the request of An Garda Síochána.
