Dear

I refer to your request, dated 21st June 2018 and received on 22nd June, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your original request sought:

The amount spent ensuring that all systems and procedures were GDPR compliant - please detail any spending made to ensure GDPR compliance to date

The amount spent on GDPR training to date

I am aware that a member of staff of this Office was in contact with you via email on 11th July 2018 in which you were informed that all records relating to your request are not held centrally. To obtain the records requested, each Section and Division within the organisation would be required to conduct a search, retrieval, analysis and extraction of each payment that may relate to ensuring GDPR compliance (including training) and cross reference same with electronic and/or manual records. To provide this analysis and breakdown would prove voluminous. I am also aware that you were provided with the details of the records that are held centrally in relation to your request. I note that you are seeking these records from January 2016 to the end of June 2018.

I further note that it was agreed on that date that the scope of your request would be narrowed as outlined below and I now make my decision based on this request:

- 1. Details of the expenditure coded to the financial cost centre associated with the new Data Protection Unit since it was established.**
- 2. Records of expenditure held by the Garda College in relation to GDPR training.**

I wish to inform you that I have decided to grant your request on the 17th July, 2018.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Part 1 of your request sought:

- 1. Details of the expenditure coded to the financial cost centre associated with the new Data Protection Unit since it was established.**

An Garda Síochána became subject to the European Union General Data Protection Regulation (GDPR) (Regulation (EU) 2016/679) since the 25th May 2018 and the Police & Criminal Justice Data Protection Directive (LED) (EU) 2016/680 from the 6th May 2018. The GDPR and LED greatly increase the rights of individuals and place additional obligations on data controllers such as An Garda Síochána.

An Garda Síochána has appointed a Data Protection Officer (DPO) to ensure compliance with GDPR and LED requirements. A Data Protection Unit with dedicated staff was established in April 2018 to support the DPO.

Details of Part 1 of your request were provided to the Finance Directorate of An Garda Síochána who have briefed this office and provided details of the expenditure coded to the financial cost centre associated with the new Data Protection Unit since its establishment. A financial cost centre was assigned in February 2018 for the newly established Data Protection Unit.

Having reviewed these records, I have decided to grant Part 1 of your request, the details of which are outlined in Table A below:

This above expenditure falls under the financial subheads of ‘Salaries, Wages & Allowances’ and ‘Office Machinery & Other office supplies’.

Part 2 of your request sought:

2. Records of expenditure held by the Garda College in relation to GDPR training.

The Garda Training College has briefed this Office and provided details of expenditure in relation to GDPR/Data Protection training. Having reviewed these records, I have decided to grant Part 2 of your request. The details of which are provided in Table B below:

The above expenditure relates to continuous professional development, professional compliance, expert staff development, conference fees, practical compliance and practitioner certificates in Data Protection and (GDPR) (Regulation (EU) 2016/679) training from 1st January 2016 to 30th June 2018.

As outlined in email of this Office dated 11th July 2018, records of expenditure relating to GDPR compliance are held throughout the organisation and are not held centrally therefore the above figures are not reflective of the total amounts expended to date in ensuring GDPR compliance and related training by An Garda Síochána.

The making of a late appeal may be permitted in appropriate circumstances.
