# Re: Freedom of Information Request FOI-000258-2018 Request Granted

#### Dear

I refer to your request, dated and received on 3<sup>rd</sup> July, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

## Your request sought:

- The top 30 monetary sanctions imposed on Gardai to be found in breach of Garda discipline in 2016
- The total number of Gardai found to be in breach of Garda discipline in 2017 and the total fines imposed.
- The total number of Gardai found to be in breach of Garda discipline in 2016 and the total fines imposed.
- The number of Gardai, if any, who were found to be in breach of Garda discipline on multiple occasions in 2016 and/or 2017.
- The number of Gardai, if any, who were found to be in breach of Garda discipline on multiple occasions in 2016 and/or 2017.

I wish to inform you that I have decided to grant your request on the 15th August, 2018.

The purpose of this letter is to explain my decision.

### 1. Findings, particulars and reasons for decision.

On receipt of your request it was forwarded to the Discipline Section of An Garda Síochána. In relation to Part 1 & 2 of your request that seeks 'The top 30 monetary sanctions imposed on Gardai to be found in breach of Garda discipline in 2016 & 2017' The figures contained in the table below all relate to an individual member and in some cases relate to multiple breaches as part of a singular discipline investigation.
