Re: Freedom of Information Request FOI-000267-2018 Request Part Granted

Dear

I refer to your request, dated and received on 4th July and subsequently clarified on 17th July, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- *The sums of money paid to An Garda Síochána for non-public duty services supplied for providing escorts for wide or abnormal loads of road haulage in the following years: 2014, 2015, 2016, 2017.*
- *Also, any emails or correspondence generated between An Garda Síochána and Cork City Council and Cork County Council in 2017 dealing with the issue of garda escorts for wide or abnormal loads.*

I wish to inform you that I have decided to grant your request on the 30th July, 2018.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Details of your request were provided to the relevant sections of An Garda Síochána who have briefed this office and provided records in relation to your request.

Part one of your request seeks ‘the sums of money paid to An Garda Síochána for non-public duty services supplied for providing escorts for wide or abnormal loads of road haulage in the following years: 2014, 2015, 2016, 2017.’ The table below provides the total sums of money received for the requested year.

2014	€ 824,735
2015	€ 387,031
2016	€ 891,633
2017	€ 1,206,493

I am refusing Part 2 of your request under Section 6 (2)(a) of the FOI Act. Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a public body for the purposes of the FOI Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of the FOI Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the FOI Act does not apply and no right of access exists.

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term “administrative records” is understood to mean records relating to the processes of running and managing a business or organisation. I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the Act.

2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number **FOI-000267-2018**.

The making of a late appeal may be permitted in appropriate circumstances.
