I refer to your request, dated 23rd July, 2018 and received on 24th July, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

The lowest score and the highest score of successful candidates from the Central Interview Board responsible for interviewing candidates from the Garda DMR West Division in the 2012 promotion competition from Garda to Sergeant (i.e. board which conducted competition's second round of interviews for Gardai from DMR West Division). The full list of successful candidates in this competition was published on February 14th 2013. (NOTE: This is solely a request for qualifying scores from the respective interview board. It is not a request for any personal information).

I wish to inform you that I have decided to grant your request on 9th August, 2018.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

On receipt your request was forwarded to Human Resource and People Development to conduct a search for the relevant records.

Human Resources and People Development have advised us that the highest and lowest score for successful candidates in the competition for promotion from Garda to Sergeant 2012 was 305 (highest) and 278 (lowest). It should also be noted that there was only one Central Interview Board for the 2012 Garda to Sergeant promotion competition.

2. Right of Appeal
