I refer to your request, dated and received on 23rd July 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- 1) The number of Gardaí by rank that transferred into each Garda Division in Dublin Region in the years 2016, 2017 and to-date in 2018
- 2) The number of Gardaí by rank that transferred out of each Garda Division in Dublin Region in the years 2016, 2017 and to-date in 2018

I wish to inform you that I have decided to grant your request on the 16th August 2018.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt of your request, a search was conducted in the Transfers Section of Human Resource Management Section and the records attached at Appendix A and B were provided. These records detail the number of Gardaí by rank who have transferred in and out of each Garda Division in the Dublin Region for years 2016, 2017 and to date in 2018.

A Garda Divisional Officer (Chief Superintendent rank) who is in overall charge of a Division has the authority to transfer Sergeants and Gardaí within their respective Division. These transfers are based on the policing needs within that respective Division. Divisional Officers are required to make tactical and strategic decisions when addressing that policing need, which includes the resourcing of sub-districts on a daily basis.

With respect to individual transfer applications, these are kept under review. Each transfer application is considered on its own merit and is fully considered within the overall context of the needs of the applicants own Division in conjunction with the needs of the Division applied for
