I refer to your request, dated and received on 26th July, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Materials providing the amount An Garda Siochana spent on medical services for prisoners in garda custody in the Cork city, Cork north and Cork west divisions for the years 2015, 2016, 2017 and to-date in 2018; and the rates payable to GPs to provide service to the gardai during normal working hours and out of hours.

I wish to inform you that I have decided to grant your request on the 9th August, 2018.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance Directorate within An Garda Síochána who conducted a search for records relating to your request. The Directorate have briefed this

office. Part one of your request seeks "the amount An Garda Siochana spent on medical services for prisoners in garda custody in the Cork city, Cork north and Cork west divisions for the years 2015, 2016, 2017 and to-date in 2018." Figures detailed in the table below are as of 27th July 2018.

Part two of your request seeks "the rates payable to GPs to provide service to the gardai during normal working hours and out of hours." The Finance Directorate of An Garda Síochána has advised that the basic rate for attendance by a GP during office hours (Monday - Friday, 9am-5pm) is \in 87.02. Outside of these hours the fee is \in 139.19. If more than one examination takes place at the same time an additional fee of \in 52.19 can be charged (Monday - Friday, 9am-5pm) or \in 95.72 if out of hours.

2. Right of Appeal
