# Re: Freedom of Information Request FOI-000318-2018 Request Refused

#### Dear

I refer to your request, dated 31st July, 2018 and received on 1st August, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána. I further refer to the clarification of your request on the 16th August, 2018 accordingly your request has now been amended and will be processed from the date of clarification.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

#### Original Request:

I am a student at conducting a research on drug policy and will like to request information on drug offences and drug offences related crime under the Freedom of Information act.

I am specifically looking for information on number of drug related arrests for minor offenses and major criminal offense, resources both human and finacial expended on policing minor drug offences and opiod related arrests. Information from 2010 to 2016.

#### Clarified Request:

To clarify my request, I am requesting information on the number of drug related arrests, made by Gardai for possession and for trafficking as well as related convictions.

If available I would also request information on the amounts actually seized in this cases.

I wish to inform you that I have decided to refuse your request on 16th August, 2018.

The purpose of this letter is to explain my decision.

#### 1. Findings, particulars and reasons for decision

Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a public body for the purposes of the FOI Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of the FOI Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the FOI Act does not apply and no right of access exists.

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term "administrative records" is understood to mean records relating to the processes of running and managing a business or organisation. As a result, the FOI Act excludes operational policing business as opposed to the defined administrative processes of An Garda Síochána.

The records sought by you relate to operational policing matters carried out by An Garda Síochána, as opposed to administrative matters relating to Human Resources, or Finance or Procurement.

I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the Act.

However, in order to assist you I wish to inform you that information relating to the quantity and value of drugs seized from 2011 to 2016 is set out in the Annual Reports of An Garda Síochána. These reports are available on the website of An Garda Síochána at the following link:
