Dear

I refer to your request, dated and received on 3rd August 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána. I understand a member of staff from my office spoke with you on 29th August 2018 and clarified your request.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

In accordance with Section 7 of the Freedom of Information Act, 1997 & 2003 & 2015 I wish to request access to the following records, which I believe to be held by your Department/organization:

I would to know how much An Garda Siochána has spent translating books of evidence and other related documents in 2016,2017, and so far this year. I would like the cost broken down by year, company hired, and language.

Your clarified request:

Costs of translation/interpretations services broken down by year and company

I wish to inform you that I have decided to part-grant your request on the 30th August 2018.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance Section of An Garda Síochána to identify records held which show the fees paid to companies relating to translation services.

An expenditure report was generated from the Financial Management System for the overall translation services costs for 2016, 2017 and to date in 2018. Appendix A attached provides a breakdown of the companies used to provide translation services. These include services such as written translations, person to person translations, telephone interpretation services and sign language.

As advised by my office, there are records held relating to translation costs and each record held may or may not identify the specific translation type conducted which incurred the cost. These records are not held centrally and in order to provide same, each record held would have to be checked manually to identify the type of service provided and the languages involved. However, in some cases the records do not necessarily have this level of detail recorded and so it is not possible to identify the languages involved from the records. As a result, the information gathered would be incomplete even if all records were researched individually. Therefore, there is no overall single record, which has the information you seek, held within the Finance Section of An Garda Síochána.

As the record does not exist, I am refusing your request wherein you are seeking a breakdown of the languages. I am applying Section 15(1)(a) in this regard which states:

Section 15 - Refusal on administrative grounds to grant FOI requests

15(1) A head to whom an FOI request is made may refuse to grant the request where
(a) The record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken

An Garda Síochána do not have statistics for the individual languages and the variance in languages sought each year can change. However, the following languages are the most frequently requested for translation/interpretation:

- Albanian
- Chinese
- Polish
- Russian
- Lithuanian
- Latvian
- Romanian/Moldovan
- Portuguese
- Arabic/Kurdish/Sorani/Pushtu
- Spanish
- French

2. Right of Appeal
