I refer to your request, dated 13th September, 2018 and received on 14th September, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I wish to inform you that I have decided to refuse your request on the 10th October 2018.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Your request was forwarded to the ICT Section of An Garda Síochána to carry out electronic searches across the Garda Síochána email system. The following email addresses were used for the purpose of the search for the period 1st January 2016 to 10th September 2017.

As a result of the search a number of emails were identified for consideration.

Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a public body for the purposes of the FOI Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of the FOI Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the FOI Act does not apply and no right of access exists. In addition, Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

Taking into account the above restrictions, as per Section 6 and Part1(n), Schedule 1 of the FOI Act, and having manually reviewed the contents of emails returned in the search results I am satisfied that the information contained therein does not relate to administrative records pertaining to human resources, finance or procurement. Therefore, I am refusing your request as the information identified falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána as a partially included organisation.

2. Right of Appeal
