I refer to your request, dated 1st January, 2020 and received on 2nd January, 2020 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

How many people passed the Fitness Test to become a Gardai in the An Garda Siochana over the previous 5 years - between 1.1.2014 and 31.12.2019? Please provide this information as an overall total, then by total males and total females, then by age bracket Under 20, Under 25, Under 30, Under 35, 36 and over .

How many people failed the Fitness Test to become a Gardai in the An Garda Siochana over the previous 5 years - between 1.1.2014 and 31.12.2019? Please provide this information as an overall total, then by total males and total females, then by age bracket Under 20, Under 25, Under 30, Under 35, 36 and over.

How many people have completed the Physical Competence Test to become a

I wish to inform you that I have decided to part-grant your request on the 28th January, 2020.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Details of your request were provided to the Garda College, Templemore to identify records containing the information you have requested. Records have been located in respect of your request.

The Sections of the Freedom of Information Act 2014 which deny access to information are known as exemptions. In this regard, I wish to advise you that I am refusing to release the records for the years 2014, 2015, 2016, 2017 and 2018 in accordance with Section 15(1)(d) which states:

Refusal on administrative grounds to grant FOI requests

15(1) A head to whom an FOI request is made may refuse to grant the request where (d) the information is already in the public domain.

The information sought by you in this request was the subject of a previous request in 2019 and a copy of this decision is published on the Freedom of Information Decision Log on the Garda website. Access to this decision may be obtained by following the link below:

This office has been advised by the Garda College that records from 01.01.2014 to 31.12.2018 do not exist in the format requested by you wherein you are seeking a breakdown on the age of the candidates. Only records from 1st January 2019 onwards record the age of the applicants on the day of the PCT/Fitness test. In this regard, I am refusing to provide such information from 2014 to 2018 in accordance with Section 15(1)(a) of the FOI Act which states:

Refusal on administrative grounds to grant FOI requests

15(1)A head to whom an FOI request is made may refuse to grant the request where

(a) The record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken,

The records you seek for 2019, broken down in age categories, are set out in the attached Appendix. Please be advised that the information provided relates to the <u>pre entry test</u> of which there are two component elements: Fitness Test and Physical Competency Test. It should be noted that both elements must be passed in order to qualify for entry into An Garda Síochána. An 'Other' result indicates that the candidates were not participating in the test due to being non-effective on the day of the test, or that they had passed that element of the test previously.

Therefore, due to the processes in place in relation to repeats/appeals/etc. the number who pass or fail does not reflect the records maintained in respect of the pre-entry tests carried out. I wish to advise that the figures provided in the Appendix attached equate to the number of pre-entry tests carried out as opposed to the number of people.

2. Right of Appeal

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
