Dear

I refer to your request, dated and received on 7th January 2019 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

The number of probationer Gardaí that were allocated to each Garda Station in Dublin in each of the 4 Garda Graduation Ceremony that was held in 2018. To help you further what I am seeking in March 2018 10 Probationer Gardaí were allocated to Store Street Dublin, 4 Probationer Gardaí were allocated to Finglas Garda Station, In June Ceremony 3 Probationer Gardaí were allocated to Dundrum Garda Station etc. etc.

I wish to inform you that I have decided to grant your request on the 23rd January 2019.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt of your request, a search was conducted in the Human Resource Management Section of An Garda Síochána in respect of same.

Please find attached the records outlining the number of probationer Gardaí allocated to each Garda Station in the DMR in the four attestations during 2018. You will note that 376

probationers were assigned to stations in the DMR in 2018. It should be further noted that probationers may only be allocated to designated training stations.

2. Right of Appeal


