#### Dear

I refer to your request, dated and received on 9<sup>th</sup> January, 2019 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

- 1. Total spending on stationary in Tuam Garda Station in 2018 and 2017?
- 2. Total number of police vehicles in Tuam Garda Station in 2018 and 2017 and the value of these vehicles?

I wish to inform you that I have decided to grant your request on the 29th January, 2019.

The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decision

On receipt of your request, a search was conducted in the relevant sections of An Garda Síochaná in respect the records that you were seeking.

Part 1 of your request sought "Total spending on stationary in Tuam Garda Station in 2018 and 2017" The table below is the total expenditure on stationary in Tuam Garda Station in 2018 and 2017.
