Dear

I refer to your request, dated and received on 9th January, 2019 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána. I further refer to the clarification of your request on the 14th January, 2019 accordingly your request was amended.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency *"insofar as it relates to administrative records relating to human resources, or finance or procurement matters"*. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Original Request:

I am seeking details relating to the ten most expensive events which which were policed, under non-public duty, by members An Garda Síochána within the Limerick garda division during the 2018 calender year.

I am seeking details of the organiser/host of each event including the amount of monies recouped by An Garda Síochána for policing services at the ten events.

Clarified Request:

I wish to confirm that my request relates to duties which were carried out within the venues and to invoices which were issued by An Garda Síochána to the event organisers.

I understand a member of staff in my office clarified your request by email with you on 14th January, 2019 and it was agreed that this office would provide the ten most expensive events policed under non-public duty by An Garda Síochána in 2018 in the Limerick Garda Division.

In this regard, I have decided to grant your request on the 23rd January, 2019.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance Section of An Garda Síochána who have briefed this office and have provided details of the top 10 non-public duty event receipts for 2018 in the Limerick Division. Please see table below which outlines these records are outlined below.

Under Section 30 of the Garda Síochána Act 2005, An Garda Síochána may provide and charge for police services for events on private property or in areas open to the public if:

- (a) It is in the public interest and consistent with the functions of An Garda Síochána to provide the services, and*
- (b) The Commissioner is satisfied that the person has paid or will pay to the Commissioner the charges for the services.*

Non-public duty is performed by members of An Garda Síochána under arrangements made with organisers of events such as football matches, concerts and race meetings, etc. who seek

to engage the services of members of An Garda Síochána to perform duties to which they would not normally be assigned.

Members of An Garda Síochána have been made available for the performance of such duties and the State has charged for their services. This work is normally performed by members who would otherwise be off duty. It is generally the practice to charge organisations for the costs of duties performed by members inside the event.

In general, the cost of policing duties performed by Gardaí outside the event such as traffic control, beat patrols and other public policing duties which would be additional to those normally performed at the location, are not paid by the organisation hosting the event but fall to be paid from the Garda Vote. However, at some specific larger events An Garda Síochána seeks a contribution from the promoters to overall policing costs. In this regard, I advise that the level of contribution to be made to An Garda Síochána is agreed by the local District Officer with the organisers, taking into account the nature and size of the event.

At all times, it is the policy of An Garda Síochána that the safety of the public must be the ultimate concern.

2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number **FOI-000023-2019**.

You must ensure that your FOI reference number (FOI-000023-2019) is included in the payment details.



The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
