I refer to your request, dated and received on 8th February, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I would like to make a FOI request under the Freedom of Information Act 2014. Under section 7 of this act, I would like access to the records held by An Garda Siochana. The information I am seeking relates the road traffic enforcement fines revenue relating to the R830 Kill Lane, Dublin.

In excel or pdf format, I am seeking the monthly monetary amount of all Fixed Charge Notices issued by An Garda Siochana on this road from 1 January 2019 to 31 December 2021, broken down by offence group (if possible).

I wish to inform you that I have decided to grant your request on the 2nd March 2022.
