I refer to your request, dated and received on 6th March, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I am looking for the number of sworn members of An Garda Siochána (Excluding Garda Staff) who have availed of the counselling services or Inspire Counselling Service for the years 2020, 2021 & 2022. If possible can this be broken into 1) Persona who have attended for these services in person & 2) Telephone Access.

I wish to inform you that I have decided to part-grant your request on the 3rd April 2023. The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the Employee Assistance Section of An Garda Síochána to retrieve the information requested by you.

I am to advise you that the records do not exist in the format as sought by you for sworn members excluding civilian staff. In this regard, I am refusing the breakdown in accordance with Section 15(1)(a) of the FOI Act.

Refusal on administrative grounds to grant FOI Requests

15(1) A head to whom an FOI request is made may refuse to grant the request where —

(a) The record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken
