# Re: Freedom of Information Request FOI-000139-2019 Request Granted

#### Dear

I refer to your request, dated 3<sup>rd</sup> April, 2019 and received on 4<sup>th</sup> April, 2019 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

Under the Freedom of Information Act 2014, I am seeking the following for years 2015 to present.

- 1: A list of current third-level education courses being paid for members of An Garda Síochana
- 2: Lists of courses where fees were signed off by John Barrett.

I wish to inform you that I have decided to grant your request on the 2<sup>nd</sup> May, 2019.

The purpose of this letter is to explain that decision.
