## Re: Freedom of Information Request FOI-000142-2022 Request Granted

*Dear*

I refer to your request, dated and received on 4<sup>th</sup> April, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- 1) The number of fixed penalty notices that Gardai issued for parking on Double Yellow Lines on Newbrook Road, Dublin 13 in the years of 2019, 2020, 2021 and to-date in 2022 in tabular form; The amount generated from issuing of these FPNs in the timeframe of the question*
- 2) The number of fixed penalty notices that Gardai issued for driving with no tax on Newbrook Road, Dublin 13 in the years of 2019, 2020, 2021 and to-date in 2022 in tabular form; The amount of revenue generated through the issuing of these FPNs in the timeframe of the question*
- 3) The number of fixed penalty notices that Gardai issued for holding a mobile phone while driving on Newbrook Road, Dublin 13 in the years of 2019, 2020, 2021 and to-date in 2022 in tabular form; The amount of revenue generated through the issuing of these FPNs in the timeframe of the question*

I wish to inform you that I have decided to grant your request on 19<sup>th</sup> May 2022.

The purpose of this letter is to explain that decision.

## 1. Findings, particulars and reasons for decision

Details of your request were provided to the relevant Section of An Garda Síochána who conducted a search for records relating to your request. The table below sets out the records sought.
