## Re: Freedom of Information Request FOI-000181-2020 Request Granted

#### Dear

I refer to your request, dated 29<sup>th</sup> May, 2020 and received on 2<sup>nd</sup> June, 2020 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

I wish to apply under the Freedom of Information Act 2014 for the following information relating to garda finances:

- a- The cost of running the Garda Air Support Unit in each of the first five months of 2020
- b- The costs of running the Garda Air Support Unit in each of previous three years.

I wish to inform you that I have decided to grant your request on the 4th June, 2020.

The purpose of this letter is to explain that decision.

#### 1. Findings, particulars and reasons for decision.

Details of your request were forwarded to the Finance Directorate within An Garda Síochána who conducted a search of their records.

The tables below details the cost of running the Garda Air Support Unit, this cost includes salaries, allowances maintenance and repairs of the respective unit.
