I refer to your request, dated and received on 4th June, 2020 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Could you provide me with the following information under the FOI Act 2014

• The number of competitions for Garda Members to join each Divisional Roads Policing Unit that were held in 2018, 2019 and to-date in 2020 in tabular form.

I wish to inform you that I have decided to grant your request on the 10th June, 2020.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Upon receipt, details of your request were forwarded to the Competitions Office, Human Resources & People Development Section of An Garda Síochána who conducted a search for records containing the information you have requested.

Please find table below which sets out the Roads Policing Unit competitions held from 2018 to date. One Divisional competition was held in this time period. The remaining competitions where held on a Regional basis. Each of these Regional competitions had a number of vacancies for both Sergeant and Garda rank within each Division for the Roads Policing Units.

As the Regional competitions were seen to fill all current and future vacancies in the Roads Policing Units up until 31st December 2020 or the 30th June 2020 depending on the Region, there have been no further competitions held since.
