Dear

I refer to your request, dated 30th May, 2023 and received on 31st May, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

a database/spreadsheet/record of all fines levied on transport operators for failing to carry out proper documentation checks for arrivals into Ireland. This database to include the name of the transport provider, the amount of fines that have been levied, the number of fines, the number of fines that were unpaid after 28 days, the number of times the fine was doubled, and any other information that is held by AGS on each fine.

I wish to inform you that I have decided to <u>part -grant</u> your request on 13th June 2023. The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Upon receipt, details of your request were forwarded to the Garda National Immigration Bureau (GNIB) who conducted a search for records containing the information you requested. GNIB have advised that while your request sought records in respect "fines levied on transport operators for failing to carry out proper documentation checks for arrivals into Ireland",

Carrier Liability fines are issued to air carriers and shipping agents/companies in respect of non-national passengers who are permitted to travel to the State without the necessary visa. The figures provided below relate to Carrier Liability fines.

Please find tables below which set out records sought in your request.

Data in respect of the number of fines which are unpaid within 28 days is not collated as the business model for each carrier differs. Some carriers settle accounts on a monthly basis while others do so on a quarterly basis. GNIB facilitate such accounting arrangements. As the number of fines unpaid within 28 days is not collated, I am refusing this part of your request in accordance with Section 15(1)(a) of the Act which states that:

Refusal on administrative grounds to grant FOI requests

15(1)(a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken

Your request also sought "the number of times the fine was doubled" and I can advise that this figure is Zero.

I am refusing your request for the name of the transport provider in respect of each fine. An Garda Síochána is a partially included agency for the purposes of the FOI Act. In accordance with Part 1(n) of Schedule 1 of the Act, An Garda Síochána is a public body for the purposes of the Act only in respect of administrative records relating to human resources, or finance, or procurement matters. The number of offences committed by a particular carrier under Section 2 of the Immigration Act 2003 is an operational policing matter. As such, the number of fines imposed on particular carriers falls outside the scope of the FOI Act as it relates to An Garda Síochána. I am therefore refusing to provide the name of the transport provider in respect of each fine levied in accordance with Part 1(n) of Schedule 1 of the FOI Act.

2. Right of Appeal

The making of a late appeal may be permitted in appropriate circumstances.
