I refer to your request, dated and received on 19th June, 2019 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- 1) The amount AGS spent on purchasing leg straps to assist them in dealing with violet suspects in the years 2017/2018 and to-date in 2019 in tabular form
- 2) The amount AGS spent on purchasing batons in the years 2017, 2018 and to-date in 2019 in tabular form; The length of each baton is; If the batons that are issued to public order officers are difference in length then please supply the two difference lengths of the batons
- 3) The amount AGS spent on purchasing riot helmets for public order officers in the years 2017, 2018 and to-date in 2019 in tabular form
- 4) The amount AGS spent on purchasing vehicle stinger devices in the years 2017, 2018 and to-date in 2019 in tabular form
- 5) The amount AGS spent on purchasing riot shields in the years 2017, 2018 and todate in 2019 in tabular form.

I wish to inform you that I have decided to grant your request on the 12th July, 2019.
