I refer to your request, dated and received on 26th June, 2019 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- 1) *The total expenditure of stationary in each Garda Station in Dublin Region in the years 2018 and to-date in 2019 in tabular form*

I wish to inform you that I have decided to grant your request on the 5th July, 2019.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance Directorate within An Garda Síochána who conducted a search for records relating to your request. The table below provides a breakdown of the expenditure on stationary for the years requested..
