## Re: Freedom of Information Request FOI-000264-2019 Request Part-Grant

#### Dear

I refer to your request, dated 26<sup>th</sup> June, 2019 and received on 27<sup>th</sup> June, 2019 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána. I am aware that a member of this office was in contact with you by email on the 28<sup>th</sup> June, 2019 wherein your request was amended and will therefore commence from this date.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your amended request sought:

- The total security cost incurred by An Garda Siochana in relation to the five visits by Prince Charles' over the last five years.
- The total amount received from promoters and organisers by An Garda Siochana to police events for each year from 2014 to 2018 inclusive; and please give a list of the top ten grossing events for each of those years.

I wish to inform you that I have decided to part-grant your request on the 16th July, 2019.

The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance Directorate within An Garda Síochána who conducted a search for records relating to your request.

Part 1 of your requests seeks "The total security cost incurred by An Garda Siochana in relation to the five visits by Prince Charles' over the last five years." The table below provides a breakdown of the cost in relation to "visits of Prince Charles" as previously advised the returns for 2019 have not yet been completed for this event and therefore are not available.

The Sections of the Freedom of Information Act 2014 which deny access to information are known as exemptions. In this regard, I wish to advise that I am refusing to release the figures in respect of the 2019 visit of Prince Charles in accordance with Section 15 (1)(a) which states:

### Refusal on administrative grounds to grant FOI requests

15(1)(a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken

In respect of Part 2 of your request wherein you seek "The total amount received from promoters and organisers by An Garda Siochana to police events for each year from 2014 to 2018 inclusive; and please give a list of the top ten grossing events for each of those years." Please find attached Appendix A which outlines the amounts received from event promoters/organisers in the years requested by you and also the top ten grossing events for those years.

Non-public duty is performed by members of An Garda Síochána under arrangements made with organisers of events such as football matches, concerts and race meetings, etc. who seek to engage the services of members of An Garda Síochána to perform duties to which they would not normally be assigned.

Members of An Garda Síochána have been made available for the performance of such duties and the State has charged for their services. This work is normally performed by members who would otherwise be off duty. It is generally the practice to charge organisations for the costs of duties performed by members inside the event.

In general, the cost of policing duties performed by Gardaí outside the event such as traffic control, beat patrols and other public policing duties which would be additional to those normally performed at the location, are not paid by the organisation hosting the event but fall to be paid from the Garda Vote. However, at some specific larger events An Garda Síochána seeks a contribution from the promoters to overall policing costs. In this regard, I advise that the level of contribution to be made to An Garda Síochána is agreed by the local District Officer with the organisers, taking into account the nature and size of the event.

At all times, it is the policy of An Garda Síochána that the safety of the public must be the ultimate concern.

### 2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number FOI-000264-2019.

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
