## Re: Freedom of Information Request FOI-000343-2018 Request Granted

#### Dear

I refer to your request dated 13th August, 2018 and transferred to this Office from the Department of Justice and Equality on the 15th August, 2018, which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

Copies of all the invoices the Association of Garda Sergeants and Inspectors (AGSI) has submitted to the Department of Justice in order to receive their annual subvention in 2017 and to date in 2018.

I have been further advised that you also spoke to a member of my staff on Friday 7th September, 2018 were it was clarified and confirmed that you would accept a table detailing the dates, descriptions and amounts of the annual subvention invoiced and paid in 2017 and to date 2018.

I wish to inform you that I have decided to grant your request 12th September, 2018.

The purpose of this letter is to explain my decision.

#### 1. Findings, particulars and reasons for decisions.

Details of your request were forwarded to the Finance Directorate of An Garda Síochána who conducted a search of their records. The details contained in the invoices received were considered in conjunction with the views which were sought from BNP PARIBAS Real Estate and Noonan Service Group Limited management team on foot of your request. As per discussions with the aforementioned and the clarification of your request on the 7<sup>th</sup> September, 2018 Table A and B below details the invoices and the amounts paid in 2017 and to date in August 2018.
