## Re: Freedom of Information Request FOI-000381-2018 Request Part-Granted

*Dear*

I refer to your request, dated and received on 13<sup>th</sup> September, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána. I am aware a member of staff of this Office was in contact with you by telephone and email on the 13<sup>th</sup> September 2018 wherein you clarified your request.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your original request sought:

*All invoices and receipts relating to counselling and therapeutic services (to include traditional, alternative or holistic therapies) procured by An Garda Siociana over the last three years.*

Your clarified request sought:

*All invoices and receipts held centrally relating to counselling and therapeutic services (to include traditional, alternative or holistic therapies) procured by An Garda Siociana over the last three years.*

I wish to inform you that I have decided to part-grant your request on the 11<sup>th</sup> October, 2018.

The purpose of this letter is to explain that decision.

## **1. Findings, particulars and reasons for decision**

Upon receipt, your clarified request was forwarded to the Finance Directorate of An Garda Síochána where a number of records have been identified and provided to my Office for review and consideration under the FOI Act.

An Garda Síochána signed a contract in 2016 with EAP Consultants Limited (now trading as Inspire Workplaces) for a 24/7 counselling service using an Office of Government Procurement Framework.

The organisation introduced the 24/7 Independent Counselling Service for Garda members, Garda staff and Garda Reserves in June 2016. The free service provides employees with immediate support from accredited counsellors over the phone and then, if needed, up to eight face-to-face counselling sessions. These face-to-face sessions take place in a location within one hour of the employee's home or place of work.

The confidential service provides counselling on a wide range of work and personal related issues including critical incidents, trauma, financial, relationships, bereavement, stress, conflict, and health. It is available 24/7 for 365 days a year.

The Independent Counselling Service is delivered by EAP Consultants/Carecall who have specialist knowledge of working with policing and security personnel having worked with the Police Service Northern Ireland, Defence Forces, the Prisons Service, and the Probation Board.

The 24/7 Counselling Service is in addition to other supports available to Garda personnel. These include the Garda Employee Assistance Service, which supports members in managing and resolving personal and work-related difficulties, and our Peer Support Network, which has numerous appropriately trained Garda members available to any colleague who has experienced a traumatic incident in the work place, as well as the support provided by An Garda Síochána Chief Medical Officer.

Your request has sought '*All invoices and receipts held centrally relating to counselling and therapeutic services (to include traditional, alternative or holistic therapies) procured by An Garda Siociana over the last three years.*'

For the purpose of this FOI request and further to your conversation with a member of staff of this Office on 13<sup>th</sup> September 2018, records in this regard were garnered from the Finance Directorate i.e. records held centrally. I herewith attach a listing of payments made to EAP Consultants from 01.01.2016 to 26.09.2018 together with the associated invoices for counselling services. The details contained in the invoices received were considered in conjunction with the views sought from EAP Consultants' management team on foot of your request.

A review of the records provided indicate that some of the information contained therein is commercially sensitive and is therefore subject to section 36 of the FOI Act. I have applied section 36 to some of the information contained in the attached records and this is outlined in the Schedule of Records.

I am applying section 36(1)(b) and (c) to the redacted sections of these invoices. Section 36 states:

### **Commercially sensitive information**

**36. (1) Subject to subsection (2), a head shall refuse to grant an FOI request if the record concerned contains—**

- (b) financial, commercial, scientific or technical or other information whose disclosure could reasonably be expected to result in a material financial loss or gain to the person to whom the information relates, or could prejudice the competitive position of that person in the conduct of his or her profession or business or otherwise in his or her occupation, or**
- (c) information whose disclosure could prejudice the conduct or outcome of contractual or other negotiations of the person to whom the information relates.**

I am of the view that the release of the complete invoices detailing the quantity of counselling sessions provided and the associated fee charged would disclose EAP Consultants' pricing structure. The pricing structure of EAP Consultants with regard to the services provided to An Garda Síochána is not known to their competitors or the public in general. If the complete records were made available to you, it is reasonable to expect that it would prejudice the ability of EAP Consultants to compete in other contracts or negotiations in the future.

I am conscious of the fact that records disclosed under the provisions of the FOI Act are considered a release to the world at large and not just the individual requesting the information.

In addition, the publication of such information could reasonably be expected to result in a material financial loss by EAP Consultants as it could prejudice their competitive position in the conduct of their business. The publication of the number of sessions provided in conjunction with the fees charged into the public domain could also reasonably be expected to assist competitors by giving them competitive advantage when seeking the same type of contracts as EAP Consultants in future. I am of the same view in respect of the bank account details of the company. Furthermore, their current customers may become aware of a difference in fees they may be applied by EAP Consultants which could in turn prejudice any current or future negotiations with these customers.

With regard to your request I draw your attention to an Office of Information Commissioner decision titled: *Mr X and University College Cork (UCC) (FOI Act 2014) case number: 150444*. This particular case is relevant as the competitive position of a commercial entity was considered under section 36(1)(b) of the FOI Act.

### **Public Interest Test**

There is a Public Interest Test associated with section 36 of the FOI Act whereby my decision must be made having fully considered the public interest relevant to this request.

I have considered the public interest issues which arise in this case and have taken account of the following factors in favour of release:

- Ensuring openness and transparency of organisational functions to the greatest possible extent.
- The public interest in members of the public exercising their rights under the FOI Act.

- That there is more than just a transitory interest by the public in this information being released.
- The right to commercial confidentiality is outweighed by the needs of the public regarding the expenditure of public funds by a public body.

In considering the public interest factors which favour withholding the records I have taken account of the following:

- Allowing a public body to hold commercial information without undue access by members of the public.
- The best course of action which is in the public interest with regard to these records.
- That An Garda Síochána can conduct its business with external contractors in a confidential manner.
- That there is a reasonable and implied expectation by contractors that financial information pertaining to services provided will be held in a confidential manner.
- That there is no overriding public interest that outweighs the right to privacy by an individual or in this case the financial activities of a service provider.

Having balanced the public interest factors both for and against the release, I decided that the public interest in preserving the information and the reasonable expectation that information can be maintained by An Garda Síochána without prejudicing future financial endeavours by external service providers outweighs the public interest which would be served were the records released to you.

I have considered the provisions of section 36(2) and decided that they do not have any bearing on the decision as the overriding interest is to protect the sensitive commercial and financial information in this case.

### **Harm Test**

Section 36 also requires a harm test to be carried out as part of the decision making process. I am of the view that the release of EAP Consultants' pricing structure could reasonably be expected to result in a material financial loss by the company as it could prejudice their competitive position in the conduct of their business. The advertising of details pertaining to counselling services provided into the public domain could also reasonably be expected to give a competitive advantage to other companies seeking similar contracts with public bodies. The company's present customers may become aware of a difference in pricing structures being offered to An Garda Síochána, if applicable, which could in turn prejudice any current or future negotiations with these customers.

In this regard, to release the invoices in their entirety may prejudice the future ability of the company to tender for future contracts both within An Garda Síochána and outside the organisation. In addition, the company would be disadvantaged if its information was released into the public domain thus reducing competitiveness.

I am therefore granting you copies of EAP Consultants' invoices in a redacted form which are attached including a Schedule of Records.

## **2. Right of Appeal**
