# Re: Freedom of Information Request FOI-000381-2019 Request Refused

#### Dear

I refer to your request, dated and received on 30<sup>th</sup> September, 2019 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

I request information on An Garda Siochana's policy on CCTV systems in use by the public whether for their businesses or their homes as follows:

- 1. I request copies of current An Garda Siochana guidance and policies in respect of the public's use of CCTV systems.
- 2. I request copies of An Garda Siochana's policies and processes for dealing with complaints from the public about CCTV cameras.
- 3. What statutory duties does An Garda Siochana have in relation to regulation of CCTV systems?
- 4. What involvement does An Garda Siochana have in the authorisation of CCTV systems? Please give details of the approval and authorisation process.

- 5. Does An Garda Siochana have a formal working arrangement with the Data Protection Commission in the regulation of CCTV systems? If so please provide details.
- 6. How many complaints have been received by An Garda Siochana from the public about CCTV camera usage to date?
- 7. I request copies of reports by An Garda Siochana in respect of public use of CCTV systems.

I wish to inform you that I have decided to refuse your request on 3<sup>rd</sup> October, 2019.

The purpose of this letter is to explain my decision.

### 1. Findings, particulars and reasons for decision

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

HR records refer to personal records of staff working within An Garda Síochána. They also relate to statistical information in respect of the organisation, e.g sick leave, discipline, retirements, etc. Financial records relate to the financial expenditure of the organisation and procurement records relate to the contracting of services and the tendering process associated with same.

Your request does not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

#### 2. Right of Appeal
