I refer to your request, dated 20th September, 2018 and received on 21st September, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

I am aware that two members of staff of this Office were in contact with you via email and your request was clarified on both the 21st September and the 3rd October, 2018.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your initial request sought:

Under the Freedom of Information Act 2014, I would like to request the release of information regarding the Garda Press Office, specifically:

- 1. The amount of staff hired by the press office since 2014, with an annual breakdown
- 2. The amount paid to staff in the press office since 2014, with a breakdown of salaries and overtime if possible

Your request was clarified on 21st September 2018:

My request refers too all staff in the press office, including members of the force and civilian staff.

Your request was again clarified on 3rd October 2018:

A record of the number of Garda staff and Garda members assigned to/working in the Press Office each year from January 2014 to September 2018 broken down by rank/grade.

I can confirm that this is some of the information I am seeking as part of my request. However, I am also seeking information regarding civilian members of staff in the office.

Please note that I have numbered your request for ease of reference throughout my decision letter.

I wish to inform you that I have decided to grant your request on the 17th October, 2018.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Upon receipt, details of your request was provided to both the Finance and Human Resource Directorates within An Garda Síochána who conducted a search for records relating to same. This Office has been briefed and records have been provided for my consideration.

2. The amount paid to staff in the press office since 2014, with a breakdown of salaries and overtime if possible
