Re: Freedom of Information Request FOI-000394-2018 Request Refused

Dear

I refer to the recent OIC decision, ref. 180211 dated 14th September and received at this office on 17th September, 2018. As directed by Mr. Rafferty, Senior Investigator, Office of the Information Commissioner a fresh decision making process was undertaken in respect of Part 4 of your initial request FOI-000133-2018 i.e. *“corresponding records on mobile phones and/or other technology that was procured to replace its items reported missing”*.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency *“insofar as it relates to administrative records relating to human resources, or finance or procurement matters”*. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

“corresponding records on mobile phones and/or other technology that was procured to replace its items reported missing”.

I wish to inform you that I have decided to refuse your request on the 11th October, 2018.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Details of your request were provided to the relevant areas within An Garda Síochána in order to identify and conduct a search for the records you have requested.

As a result of this search this Office has been advised that “*corresponding records on mobile phones and/or other technology that was procured to replace its items reported missing*” do not exist.

I am refusing your request on administrative grounds in accordance with Section 15(1)(a) of the FOI Act which states:

Refusal on administrative grounds to grant FOI requests

15. (1) A head to whom an FOI request is made may refuse to grant the request where —

- (a) *the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken,*

An Garda Síochána do not procure equipment specifically to replace lost equipment as they maintain a constant supply of devices to ensure continuity of service.

2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number **FOI-000394-2018**.

You must ensure that your FOI reference number FOI-000394-2018 is included in the payment details.


