## Re: Freedom of Information Request FOI-000398-2022 Request Granted

#### Dear

I refer to your request, dated and received on 9th November, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

I would like to make a FOI request under the Freedom of Information Act 2014. Under section 7 of this act, I would like access to the records held by An Garda Siochana. The information I am seeking relates the road traffic enforcement fines revenue relating to the R830 Kill Lane, Dublin.

In excel or pdf format, I am seeking the monthly monetary amount of all Fixed Charge Notices issued by An Garda Siochana on this road from 1 August 2022 to 31 October 2022, broken down by offence group (if possible).

I wish to inform you that I have decided to grant your request on the 6th December 2022.

The purpose of this letter is to explain that decision.

## 1. Findings, particulars and reasons for decision

Upon receipt your request was forwarded to the relevant Section of An Garda Síochaná who have provided records to this office in response to your request.
